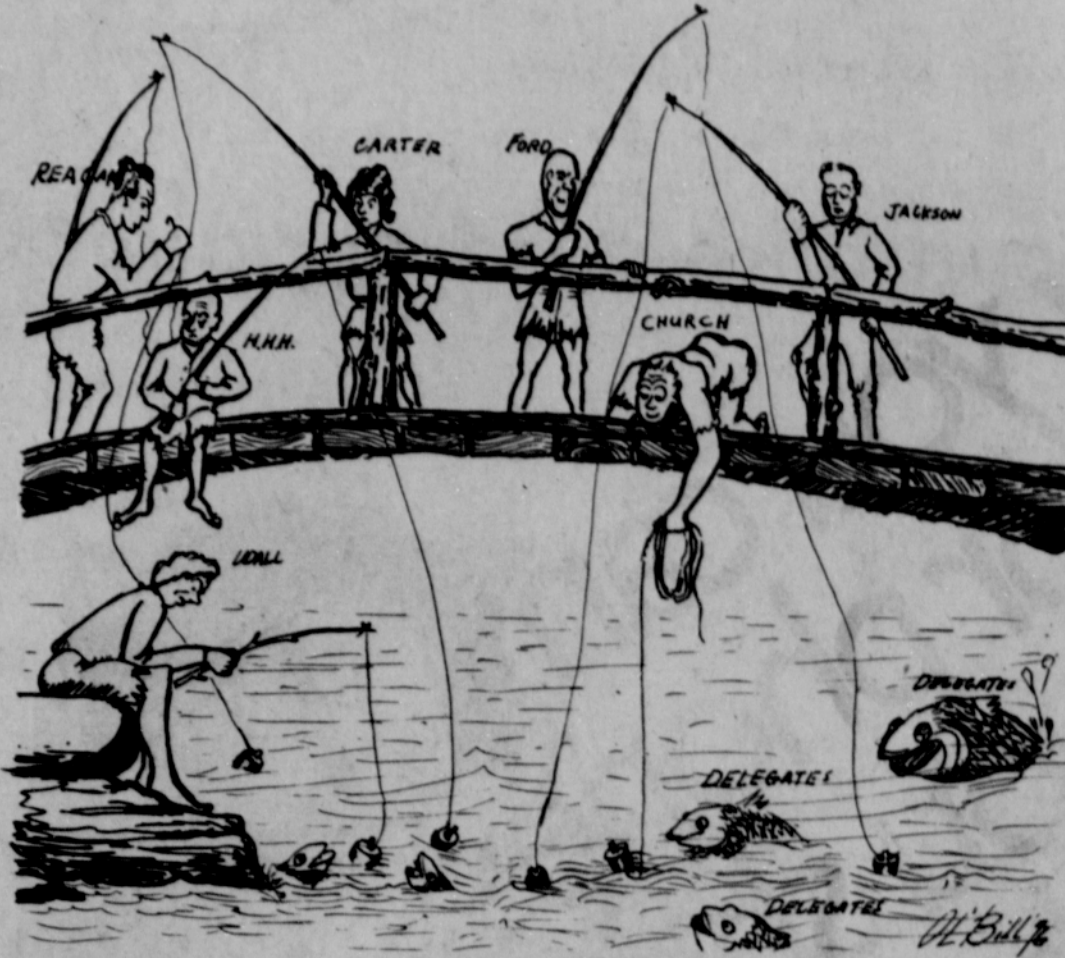

**Plan Preview Helpful**

A series of meetings on a comprehensive plan for the Sandy Rural Fire District will conclude Tuesday with a final meeting beginning at 7:30 in the district's main station.

The district has asked a committee of citizens from the area to discuss policies and plans on a five and 10 year basis during the previous three meetings of the series.

At Tuesday's meeting the committee is scheduled to make its recommendations on the district's proposal which will effect fire protection in the Sandy area for years to come.

Personnel, equipment, property, training, financing and a fire prevention program have been among the items discussed by the committee in its study of the comprehensive plan and the group's

decisions will help the district's board in setting its goals for the future.

No matter what the committee's conclusions are about the proposals it has heard and reviewed, the fact that the plan was presented will be of benefit to both the district and its residents. For the give and take of the public sessions has allowed the plan to be examined by a variety of interested people in the entire community. Any weakness in the plan should be talked over by this review and its strong points emphasized to the public.

Whether the committee accepts the entire plan, revises parts of it, or rejects the whole thing, we will have better fire protection in the future because the district has taken the time now to look at what it believes its needs will be tomorrow.

**A Privileged Class?**

The timing could not possibly have been worse.

On the same day that the State Board of Higher Education ordered tuition increases for students, Chancellor Roy Lieuallen proposed that state tax money be spent to support the athletic programs at Oregon, Oregon State and Portland State.

The average student thus has to come up with more cash to stay in school while the already-pampered athlete gets a public subsidy. Lieuallen's proposal will put an estimated \$400,000 into athletic department coffers at the three schools, money which it seems to us could much more

wisely be spent minimizing tuition hikes.

The extra funds for athletics technically are ticketed for "non-revenue sports" like golf, tennis, wrestling, etc. But the net result will be bigger expense accounts for football and basketball.

And with tax money yet. Most people are pretty unhappy about their taxes as it is. We just can't see shutting off other deserving programs so that Oregon or Oregon State sometime might beat USC in football.

We think Chancellor Lieuallen has his priorities badly askew.

**A "New" Jackson Emerging?**

With none of the Democratic presidential candidates exactly catching fire, it's fascinating to see the strategy change in the camp of Sen. Henry M. (Scoop) Jackson.

Up until now, Jackson has tried to stake a position in the center of the Democratic spectrum. But Jackson strategists obviously feel this isn't working and now he's trying to outliberal the liberals.

He's particularly concentrating on the labor vote, which he must have to win. Because of his stand on Vietnam, Jackson never will be accepted by the far-out liberals. But if he can convince enough union members of his liberalism, he could get by.

The "new" Jackson strategy is evident in press releases. Just this week, an AFL-CIO official is quoted that "year in and year out, Jackson has consistently voted right by labor's scorecard."

An accompanying breakdown gives Jackson a 97 per cent "favorable"

rating by the AFL-CIO, compared to 93 per cent for Birch Bayh, 89 per cent for Morris Udall, and 85 per cent for Fred Harris. Jimmy Carter and George Wallace are listed as having a "poor labor performance as governor of right-to-work state."

Jackson's strategy, however, seems aimed as much at non-candidate Hubert Humphrey as against anyone else. Unless Jackson can tie up the union vote early, Humphrey will take it all at the convention.

In a year when most voters seem to be converging on the center, a Jackson retreat back to the liberal left is a questionable if not downright puzzling maneuver. His strategists must be very worried.

Will it work? Will the "new" Jackson sweep the remaining primaries? Time alone will tell, but watch the New York primary. It could be crucial.

**Quality Education Needed**

Gov. Bob Straub spoke for a lot of people last week when he said the voters would vote more money for schools "when they're satisfied with the product."

The governor said people feel let down by the quality of education and predicted that financial support would be forthcoming only when the school structure is doing a better job.

Obviously, it's unfair to blame all the problems of education today on the educators; parents, in particular, must share part of the blame.

But educators simply cannot duck responsibility for what they are not

doing. They are not teaching students to read properly, to spell properly, to speak and write properly.

Discipline needs first and foremost to come from the home. But it also needs to be asserted in the schools. Some teachers seem actually to condone disrespect of authority.

Finally, teachers need to quit complaining that they're economic orphans. As Gov. Straub says, the people will vote more money when they're convinced a better job is being done in our schools. And not until.

**Committee picked to screen candidates for MHCC president**

Initial meetings of a screening committee named to aid in the search for a new president of Mt. Hood Community College will be held later this week.

The MHCC board several weeks ago named a California educator, Dr. Stephen Epler of Fremont, as a consultant to aid in the selection process.

At last Wednesday's board meeting, a 15-member screening committee was named and Dr. Epler will, in turn, meet with members of the committee later this week.

The three public members appointed by the board are Bobby Bouneff of 740 NE 107th Pl., Mary Bredekamp of 36585 SE Bluff Rd., Boring, and George Howland of 14040 SE Raymond. Bouneff is a Portland attorney, Mrs. Bredekamp is associated with Scenic Fruit, and Howland is a bat-

alion chief in Fire District 10. Chosen as alternates were George Morgan of Sandy, Elsie Lancaster of 26202 SE Cochran Rd., and Dale Brown of 3220 SE 268th.

Named by the Management association at the College were Gleason Eakin, Jack Miller and Robert Wesley; by the faculty Rob Breece, Robert Kull and Maxine Olson; by classified personnel Ruth Kephart, Mike Stuart and Homer Taylor; and by students Shawn Adams, Paul Dunbar and John Klem.

The committee will recommend a list of possible successors to Dr. Earl Klapstein, president since the College's inception who leaves April 17 for a new job as president of Los Rios Community College, near Sacramento.

**Portland approves generators**

The Portland City Council Tuesday gave informal approval to installation of three hydroelectric generators in the city's Bull Run dams.

The generators would be financed through a \$19.7 million revenue bond sale. They would produce an estimated 114,000

megawatt-hours of power annually which the city could sell to area private utility companies.

It would take three years to install the generators. City administrators say they plan to apply for a federal permit to allow the project.

**Boring School to ask for tax base**

Boring School District board will ask voters to approve a new tax base in the May 25 primary election.

The proposed tax base is \$747,453. The present base of the district is \$381,115.

In the past six years, there have been no budget elections in the Boring district. The district has been able to operate within the tax base.

"The school board feels that the present tax base will be inadequate next year," said district superintendent Dave Gillespie.

"We need the new base in order to maintain and enhance

our program," he said. The board decided that going for the tax base in the primary was better than waiting for the general election in November, according to Gillespie. The decision was made in the February board meeting.
