Sandy man trains with fourth dog

George Wright of Oral Hill Road, Sandy, trained at Guide Dogs for the Blind in San Rafael, Calif., with his first dog guide in 1957.

Since that time, he has received two other dogs from the San Rafael school and is currently training with his fourth, a golden retriever named Quarter.

Wright and his 15 classmates were officially presented their canine partners in outdoor graduation exercises last Saturday by the 4-H members who raised them from puppyhood as an accredited project.

Wright and his wife, Dolores, who also uses a guide dog, divide their time between their Sandy and San

Diego homes. He recently retired from Peralta Hospital in Oakland after almost 30 years as a darkroom technician.

Wright's guide dogs were he mainstay during those years, getting him back forth to work with safety and confidence. "I'm lost without a dog at my side," he said recently.

Fawbush reviews legislative session

The 1981 session of the Oregon Legislature was the longest in the state's history as legislators wrestled with funding and budgeting questions.

While monetary considerations got the majority of the spotlight, a number of good bills came out of the marathon session, according to Rep. Wayne Fawbush, D-Hood River, who will continue to represent Sandy until January 1983 when new legislative districts become effective.

"The most important bill to come out of this session," said Fawbush, "is the bill to continue LCDC, the Land Conservation and Development Commission."

He said LCDC has been subjected to much criticism since it began in 1973, however, those criticisms should be taken care of with action taken in the 1981 session.

"Months of debate resulted in the continuation of a strong, central land use planning agency to review changes when necessary, but strengthening the con-

cept of local control that makes Oregon's land use planning process unique in the nation," he said.

The 'lot of record' bill will help those who purchased parcels with the hope of building on them, but who have been prohibited by subsequent zoning. "This should help many people who have planned to build retirement homes while, at the same time, not opening up too much agricultural land to development," Fawbush pointed out.

"I spent six months working on a bill that would help homeowners avoid a devastating 'pay-twice' situation," Fawbush said.

The representative said he received calls from a number of constituents over the last two years who had paid contractors for construction work and later discovered that those contractors had not paid for materials or labor.

Consequently, the homeowners found themselves with liens against their property that could result in a foreclosing

or subsequent loss of the home, if not paid off.

"While the lien laws have been on the books for a hundred years and are there to protect laborers and material suppliers, we can't just overlook the rights of the homeowners," Fawbush said. "We worked with consumers and industry representatives to help homeowners protect themselves by being notified of this possible pay-twice situation early on in the construction contract."

"We also are making it possible for homeowners to learn exactly who is working on the job site and how much debt the general contractor is building up. No one should have to enter into this situation unaware of the possibility of liens," he said.

As chairman of the Environment and Energy Committee, Fawbush was able to work on one of the most comprehensive energy packages in the nation.

"I entered this session determined to help all homeowners be able to weatherize their homes," he

said. House Bill 2246 mandates electricity and natural gas providers to offer weatherization incentives, either by offering rebates or low-interest loans to their customers.

"Although users of wood heat and oil aren't covered in that bill, they are covered in companion bill 2247, which provides low-interest loans

to these heat source users who choose to weatherize.

"I believe we went much farther than the governor proposed in his weatherization package," Fawbush said. "These incentives will encourage weatherization and conservation, and conservation is the cheapest way to produce more energy for Oregonians."

Boring school board names Byrd to fill vacant spot

Michael Byrd, a self-employed contractor, joined the Boring School Board as a member recently.

He was appointed to Position 5, vacated by Dixie Whitmore on July 1, when a motion to appoint resident Linda Shaw died for lack of a second. Byrd and Shaw were the only candidates for the position.

"Gentlemen, we have a hard decision to make tonight," Chairman Gale Meier told the board. "We have two equally strong candidates to choose between. Does anyone have any suggestions to make it easier?"

As board members pondered the question, Meier suggested tongue-in-cheek that "we take a short coffee break . . . and duck out the back door." The board considered, but dismissed the possibility of a secret ballot.

Byrd, who received 97 votes in an unsuccessful quest for board member's Shig Nagae's position, told

the board in a letter of application that his running for the position shows he is "sincerely interested." He was previously on the district's budget committee.

The board voted to 3-1 to appoint Byrd. Board member Stuart McKenzie,

whose motion to appoint Shaw was not seconded, cast the dissenting vote.

Byrd's appointment means the board must fill three vacant budget committee positions in September. Letters of application will be accepted until Sept. 1.

Bid accepted for jail work

Clackamas County Commissioner Ralph Groener briefly returned from vacation to break an impasse in awarding the county jail contract last Thursday.

Groener broke a deadlock between Bob Schumacher and Stan Skoko to choose Balsiger, Shewbridge and Associates as the architect and Elliot-Jochimsen Construction Inc. as the builder.

The contract is for an addition to the county detention facility and will cost just more than \$1.5 million.

Schumacher had supported the other finalist BJSS Architects and Planners with Emerick Construction.

was to be on vacation until this week, but he stopped to get a draw on his pay. He said he would only sit in long enough to break the impasse.

Carole Berggren, county fiscal analyst, said it was important to get the issued passed, "because every minute we lose costs us money."

She explained that the jail addition is being funded through a levy for \$1,577,000. Clackamas County is doing it backward, she said. Most jobs are put out to bid and the agency chooses the low bidder.

In this case, however, the amount of money is fixed, so the county asked for proposals based on the final

cost. The impasse resulted when Skoko and Schumacher disagreed over the experience of the firms. Balsiger, Skewbridge and Associates have never built a jail, said Phil Balsiger, partner in the firm. Schumacher had supported BJSS Architects and Planners because they have built at least one jail.

Groener made his decision after Balsiger told him at the meeting that his firm had secured Walker, McGough, Foltz and Lyeria, a Washington firm that has built jails all over the West Coast. Schumacher had earlier said that firm was the best-known jail designer in the world.
