On February 22, at the hour of 9:00 a.m., at the Courthouse Annex, 906 Main Street, Oregon City, Oregon, the Board of County Commissioners will consider a review of the Clackamas County Hearings Officer's denial of a subdivision request to develop a 192 lot mobile home planned unit development subdivision. A waiver of Article VI-B-1, O-a-(2), requiring connecting roads within the subdivision to the adjacent County road to be a County road, has also been requested.

Unless otherwise provided by the Board of County Commissioners under Section 1304.06 of the Clackamas County Zoning and Development Ordinance, the review of the decision shall be confined to the record of the proceedings before the Hearings Officer. The Board of County Commissioners may admit additional testimony and other evidence without holding a new hearing or hear the entire matter again, if it is satisfied that the testimony and other evidence could not have been presented at the initial hearing.
