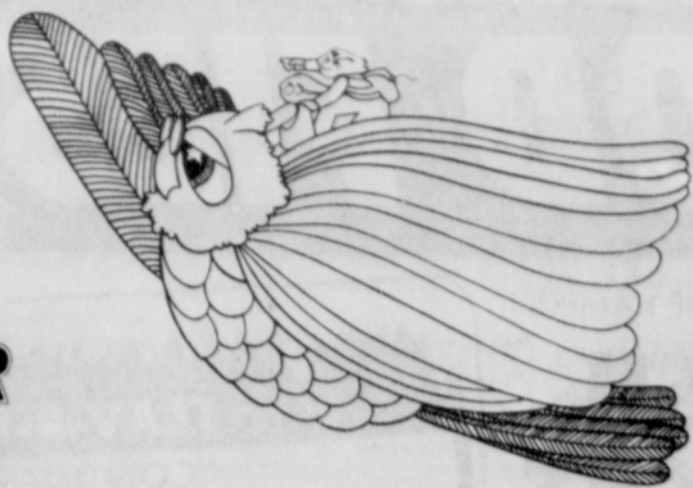

would have noticed the error, it would have probably not made any significant difference."

Cabral said that he is also concerned about where the notices were posted.

Cabral said that he identified each pole by checking the Boundary Commission's file. When he went out to determine the location of each he discovered that some were "out in the middle of nowhere, 50 to 60 feet off the road."

"Who would stop along the freeway (Highway 26) to read a notice posted on a telephone pole," asked Cabral.

"Even Clackamas County Commissioner Ralph Groener, back in October, stated at the hearing concerning ECOS recognition as a community planning organization, that he does not read such notices either."

"They (the commissioners) did not approve the recognition of ECOS, based on this. Groener said that even though they did meet the requirements (of the public notice ordinance), it wasn't enough."

"In this case, maybe the Boundary Commission did meet the bare minimum requirements of the law, but the proper notification was just not there."

"The signs, like the public notices printed in the public newspapers, were not accurate."

"So what is the difference between that decision and the annexation hearing?"

Won said that there is nothing that anyone can do about the decision today. She said that "the law provides an explicit appeals period, which is 60 days."

**RECOURSE DOUBTED**

She said that she doubts that there is any recourse, except for a lawsuit, since close to two years have passed since the annexation. She said it would be difficult to try and contest the action of the Boundary Commission at this late date.

"The only way to rectify any procedural error, if an error was made, is to call attention to it during the time of the hearing," said Won.

Cabral would not be specific on any action that ECOS might take, but did indicate that he would not rule out legal recourse.

"This all stems from the people having no input in the Boundary Commission hearing. Today's problems with development are based on this annexation. The misleading public notices were done deliberately."

"Money interests wanted it developed; the majority of the people didn't."
