He was raised in Klamath Falls, Or. and attended Roosevelt, Keno, Mills, Ponderosa, KU schools. He played kids sports, (skateboarding, bicycling, baseball); he played Jr. high football, track; high school pole vault; city league tennis/volleyball. He did some break dancing and performed on stage at a KF's Catholic church (I understand this was filmed), and the YMCA, and taught break dancing at the Y. He graduated LCC, and U. of O. (with honors) with a M.Ed. He taught school in Eugene/surrounding areas. As a local teacher he coached JV volleyball. Summers he coached little league soccer, basketball. He played city league soccer, volleyball. He played the drums and guitar. He loved snowboarding, golfing, and especially windsurfing at the Columbia Gorge and North Shore, Maui. He moved to Maui in early 2000, was employed full-time as a highly qualified math and immersion teacher at a local high school. He earned his Hawaii State Teachers and Special Education Licenses while residing there. He was loved and admired by his students.
