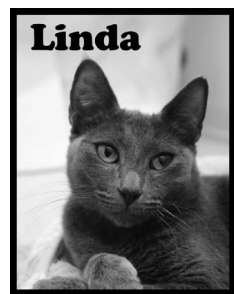

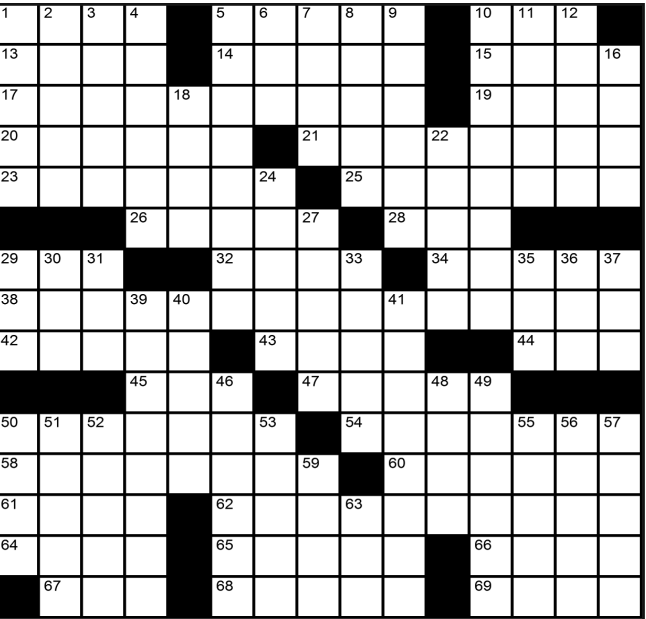
WIGGLY TAILS DOG RESCUE
