Farrell Sunderland Now Discharged

Farrell Sunderland, son of Mr. and Mrs. Roy Sunderland, returned to Brookings, Monday, after receiving his discharge from the navy.

Sunderland, veteran of two and a half years of naval service, spent most of that time in the Pacific with naval communication units. His most recent assignment before returning to the states and discharge, was on Okinawa. While stationed on this island doorstep to Japan, young Sunderland went through two typhoons which worked havoc with the U. S. forces there.

In describing the typhoon, he explained that he and a group of his buddies took refuge in one of the Okinawan tombs, and from it had a good view of the terrific destruction being done by the 150-mile an hour wind. He said that the first typhoon to strike tore their tents into shreds. When this storm abated, new tents were issued, and they were no sooner up when the second "blow" came along and destroyed them, too. Debris was flying around in the air, and about the only safe place to be was in an air-raid dugout or one of the many tombs about the countryside.

While in the Pacific, Sunderland was stationed on Ulithi, Pearl Harbor and Guam, besides Okinawa. When discharged, he held rating of seaman, first class, striking for signalman. Sunderland says that it is a little too soon after his discharge to make any definite plans. For the present, he wants to become acquainted with civilian ways, and enjoy being back home with his folks.
