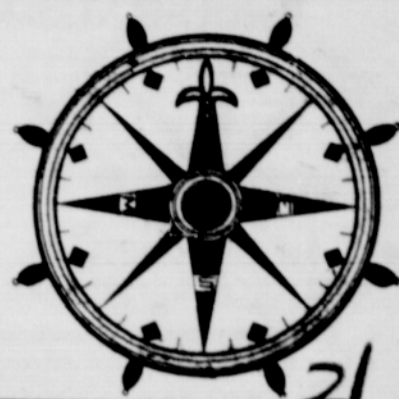

A Packard car, bearing California license and drawing a big house trailer, while attempting to pass a lumber truck belonging to Swan Lumber Co., Tuesday, did not calculate his distance properly while pulling back into the right lane, and to this was added the "jack-knifing" of his trailer.

Too close was the truck which "plowed" into the trailer, and trailer and truck went into the ditch, just north of Harris Park near the Vaughn place.

The trailer, quite an elaborate affair, was damaged possibly beyond repair. The damage to the lumber truck was not determined at the time this paper went to press, but was estimated to be little extent.

Tourists who stopped, and the state police who investigated the accident, wondered how anything but death could be the lot of the truck accident, from which Allen Ettinger walked without a scratch, and the only thing he complained of was a sprained finger.

District Budget Set Aside By Ore. Tax Commission

Finds Law Not Substantially Complied With at Meet.

Schools in this area will not open on September 2, as was first planned, it may be September 15, and probably later, depending upon a third budget vote which is yet to be planned, because of a ruling made by the state tax commission last week, following petition from a group of 13 who alleged that the law was not "substantially adhered to" in voting the budget.

Set aside on three counts, the budget was alleged to be illegal because (1) that no discussion was permitted at the meeting; (2) that the 1946-1947 tax rolls had been used and (3) that the budget had been illegally published in the Pilot.

The tax roll used was the one sent to the school board by the county assessor and tax collector, and was said to be the only legal one to be used. The budget was published in June 26, and July 3 issues of the Pilot, with a third being run gratis by the Pilot on July 10 for purpose of explanation editorially.

"There is no money to open schools, nor can they be opened until a third budget is voted," Howard James, school director, told the Pilot Wednesday. "The ruling made by the state tax commission wiped out everything for us, and we could not dare open up the schools at the originally-scheduled time."

Adhering to the legal days of publication, the earliest possible date of the budget meeting will be September 15.
