

Curriculum For High School Announced

Minimum Requirements Listed For Graduation

Seventh and eighth grade subjects will remain somewhat as they are with work being handled on a departmentalized basis. Classes in science-health, science, writing-spelling, language, and physical education. Subjects in these two areas are required.

According to Mr. Hampton, the subjects to be offered this year are: *English, General *General Mathematics, *Geography, *Physical Education and Health.

Electives: *English 2, *Biology, *Typing 1, *Mechanical Drawing, *Geometry, *Spanish I, *Physical Education.

Electives: *English 3, *American History, *Mechanical Drawing, *Spanish 1 (2 years required), *Bookkeeping-commercial.

Electives: *English 4, *American History, *Bookkeeping, *Woodworking, *Spanish I (if the subject is not included in the eight electives specifically required for the graduation).

All subjects marked thus are required. Algebra and Geometry will be offered every other year; English 1 and 2 will be alternate years; American History must be taken by seniors this year, as social economics was taken last year.

State requirements for graduation from a standard high school are: 3 units of English (one taken four); 2 units of American history (American history and social economics); 1 unit of physical education; 2 units of Science, Mathematics and foreign language; 8 units of elective courses. A total of 16 units are required.

Attention is called to the fact that the High School Standards Committee further emphasized that the requirements for graduation also constitute minimum entrance requirements for institutions outside Oregon, and departments in Oregon which require more special training than is provided in the minimum entrance requirements agreement.

Students who plan on entering institutions should, if possible, bring a catalog from the institution which they think they will attend, so that the entrance requirements can be checked, and followed in the facilities of the institution. Six-year high school graduates.

Many independent colleges and many state colleges accept students from other ten or fifteen per cent of the graduating class scholars. It can not be too strongly emphasized that any student who plans to attend college apply himself in his school work. Incidentally, this would mean that only about 500 students would be included.

Mr. Hampton, superintendent of schools, is a graduate of Pacific College, where he obtained his A. B. degree in 1931. Since then he has attended Oregon State College in 1933 and the University of Oregon in sessions in 1934, 1937, 1938, and the University of

Oregon extension school at Portland in 1946. He holds a life certificate in Oregon, an Oregon Administrative Credential, an Oregon Superintendent's Credential, and an Alaska Superintendent's credential. Previous to coming to Brookings he served as high school principal at Florence, Superintendent-principal at Harper and Haines, and as Baker county school superintendent, and as Baker county district auditor. He is a member of the state educational association, the national education association and national association for business education. He is also a member of Brookings Rotary club.

John K. Ginther, instructor in woodwork and mechanical drawing, and seventh and eighth science and mathematics, is a graduate of Lebanon high school. After graduation he attended the Eugene Bible school in 1928-1929, University of Oregon in 1929-30 and Oregon Normal School where he was graduated in 1931. In addition he has taken specialized war training in industrial arts at California Institute of Technology. His previous experience includes teacher in various Oregon schools and in Valentine, Nebr., and in addition teaching adult classes in war training industrial arts at Los Angeles. He holds an Oregon special Industrial arts certificate valid for high school. He is a member of the local Rotary club and is the scoutmaster here.

1000th Loan Given GI Home Owners

SALEM—The 1000th application for a loan under the Oregon veterans' farm and home loan act was announced this week by the state department of veterans' affairs, nearing the start of its third year of operation. The applicant was Chester O. Stollard of Nelscott in Lincoln Co. on the Oregon coast, and appraisers are now acting on the application. Loan Director Al J. Crose said.

Increasing interest is being shown by World War 2 veterans in the state loan since the legislature raised the maximum loan amount to \$6000, according to Crose, who said that 200 applications have come to the department in the past three months—a record since the loan went into operation in the autumn of 1945.

Of the 1000 applications to date, 542 have been approved, 115 are pending, and 352 were cancelled. Most of the cancellations were due to the fact that the purchase price exceeded the appraised value of the property, and the veteran could not use the loan.

Also announced this week were the first loans to be completed in Hood River County. Warren L. Henry asked for and was granted a \$5000 loan to purchase a 17-acre farm and buildings on the Mt. Hood highway, three miles northeast of Parkdale, and Dennis S. Stratton was granted a loan of \$3500, the amount he asked, to buy a 10-acre farm and five-room frame house on the Mt. Hood highway at Odell Junction, seven miles south of Hood River.

World war 2 veterans who were Oregon residents before entering service can borrow up to 75 per cent of the appraised value of the property, but not more than \$6000, for the purchase of farms and homes under the act. Interest is at 4%, and the borrower is given up to 20 years to repay. Applications are made through the Oregon Department of Veterans' Affairs, state library building, Salem, or at 416 SW 11th Avenue, Portland.



In The Mailbox:

Editor Pilot: Lily growers are still asking about the price of lily bulbs and you can be assured they appreciate the part you take in helping to stabilize the lily business—the one thing that has built so much for this county.

On the 5th of August many growers received this letter from a bulb buyer:

"Dear Sir, We have an opportunity to sell about twenty thousand Croft lilies, sizes sevens to eights, but very competitive. Our competitor quoted a price of 5c per bulb on them and we will have to meet it or come near to it."

"If can supply these packed four hundred to this case (this will probably require a somewhat larger case than what you are using) for shipment no later than Sept. 1, so please advise and quote."

This buyer evidently wants to find out whether or not lily growers have any sense of ethics or not. He knows the price has unfortunately been set. He probably had as much to do with reducing it to where it is as any buyer. No buyer nor grower wants it any lower.

Growers can't operate on a price lower than 10c, 20c, 25c and

30c. Labor is still as high as ever, so is fertilizer, spray, boxes and buildings, freight, machinery, etc. Greenhouse men will grow other plants rather than have lilies cut so low they can't make anything on them. All buyers who have any sense of ethics at all don't ask any one—no matter how green he may be at his business—to cut the price. If any lily grower sells his bulbs below the set price it is his own doings. No reliable buyer or grower wants him to do so. You can't sell any more bulbs at a cut price than you can by playing fair with yourself and all concerned. Holland has made a success of bulb business for years because the growers have one price and stick to it.

Mr. Farmer of the Co-op and all reliable growers have agreed to stay by 10c, 20c, 25c and 30c for lilies this year. Yours for the welfare of our county. — May T. Stafford.
