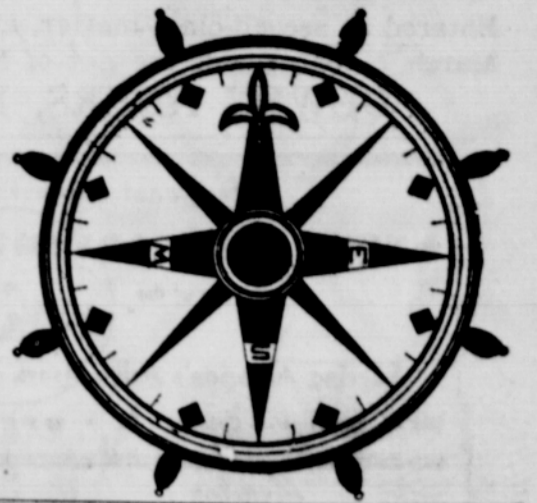

## Trout Limits Will Remain Same, Is Commission Edict

GOLD BEACH—Oregon State Game Commission met in session at Portland, Friday and Saturday to set proposed regulations for the 1950 angling season. Requests for changes in angling laws were received and considered from hundreds of sportsmen and organizations throughout Oregon. The general trout season was set for the state west of the Cascades as April 15 to Oct. 15. May 1 to Oct. 15 was the general season set for areas east of the Cascades. Exceptions were made as problems were presented in fishery management.

Regulations affecting Rogue River remain primarily the same as in 1949. Proposed changes include opening the Illinois to silvers salmon fishing from the mouth upstream to a point 400 feet below Pomeroy dam. Season on silvers is proposed from September 1 to Nov. 30 for all open salmon waters of the basin.

Steelhead season was changed on the Illinois to open Oct. 1, instead of Dec. 15 as in 1949. Daily bag-limits for salmon remain the same, but the weekly limits was changed from 4 to 5. Elimination of the Rogue regulation forbidding night-angling for catfish was considered; and the regulation was retained for reasons of law enforcement.

A salmon and steelhead limit card is proposed to limit catch of steelhead and salmon over 20 inches in length to 20 fish per year in all waters of Oregon. No split is contemplated for spring and fall fish, however. This card, if adopted, will be issued free with each license purchased and will require a punch and date for each fish over 20 inches in possession.

Fishermen who may wonder why they can't catch fish in the Chetco may lay part of the blame on the high water but a sea lion has been playing about. He has been seen by local people up the river as far as the North Fork. This is reported to be the first time one had been seen so far from the ocean.

## THE DOCTOR IN COOS AND CURRY

S. military forces at Fort Orford, he showed himself to be a man of culture, character, industry, ambition, and in every way a gentleman who was a credit to his profession, both as a doctor and as a soldier.

We can look back now, nearly a century, and realize and appreciate the heritage that he left to us, his book, "Journal of Army Life." Through his writings, we have an interesting and fairly vivid picture of that enticing section of the Oregon coast — in peace as well as in war time.

The larks and the robins seem to enjoy it wonderfully; and even the monsters of the mighty deep appear to be aware that the elements have ceased their warfare, for they may now be seen in large numbers in the harbor. 'Tis wonderful how high a whale can spout the water."

And the next day his thoughts turn homeward as he records in his book: "December 25, 1855. Christmas! This day of all others reminds us of home. Oh, how our hearts yearn for those fond ones left behind; for the many fireside re-unions of our childhood; when we felt supremely happy if our kind mothers allowed us plenty of ginger cake and lemonade. If our wants were as simple now, how much happier we might be; yet, after all, there are a few of us, I presume, who would be willing to
