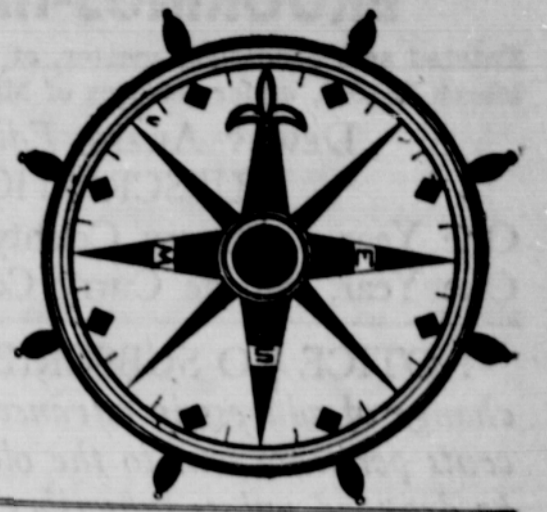

School 'Shifts' Revealed; Registration Dates Set

All freshmen and sophomore students are asked to register Monday, August 20, 1951, in the elementary school office. Registration is set from 2:00 until 4:30 in the afternoon.

Junior and senior students are asked to register on Tuesday, August 21, from 2:00 until 4:30 in the afternoon.

Any pupil who is working during the day is asked to register on Tuesday, August 21, from 8:00 until 10:30 in the evening.

It is hoped that all of the high school students in the community will register on the dates set.

High school hours are set earlier this year in order to facilitate transportation. High school is to commence at 8:15 in the morning and continue until 3:00 in the afternoon.

Present plans call for the country children in the elementary grades to come in to the morning shift, with school beginning at 7:45 and continuing until 12:15, and the afternoon shift beginning at 12:45 until 5:15. Both high and elementary

pupils will be brought in from the far ends of the routes on the first run, with high school pupils living nearer in on the bus route being brought in on the second trip which will take care of the shorter run. Last year the buses carried an overload. In this way the overload can be cared for, and at the same time only one trip is necessary in the morning to the far end of the route.

Actual details of the transportation and shift will appear within the next two weeks. Also list of elementary assignments.

When high school starts on September 4, four new teachers will greet the pupils. Miss Tyler, graduate of Humboldt State college, will teach home economics, and girls' PE; Mrs. Audrey Ingram, graduate of Arizona State college with further work at Armstrong college at Berkeley, Calif., will teach commerce, chorus and biology. Mr. Harold Sergeant, graduate of Oregon State college, will teach science and mechanical drawing and senior math, and Mr. Marvin Wiggins, eighth grade teacher, will conduct band.

Former teachers remaining on the staff are: Arthur Guthrie, coach, boys' athletics and social science; Mrs. Catherine Doherty, English, and Carl Harrison, typing and mathematics. Superintendent-principal, Lynn Hampton.

Del Norte Fair Starts This Fri.

CRESCENT CITY, Aug. 16.—A festive air fell over Del Norte county this morning. The 55th annual showing of the 41st district fair got underway here this morning as visitors began flocking to the Del Norte county fairgrounds.

The annual three-day event gets underway officially at 10 a.m. as Del Norte Horsemen's Association members lead a grand opening parade in front of the grandstands and judging begins for all divisions of the fair.

More than 5000 entries will be judged in all divisions, Les McClure, fair manager, announced today as he was completing final tabulations.

Among the exhibitors returning to the Del Norte fair in the livestock division is Twing Starr, one of the oldest exhibitors in the state from the standpoint of the number of fairs in which he has entered livestock. A professional exhibitor, Twin, who does not disclose his true first name, will again enter jerseys in the 1951 Del Norte fair.

Other livestock exhibitors returning to the Del Norte fair from outside the county are the Laytons, Yreka ranchers, who will display milking shorthorns.

Tony Cosgrove, who winds up his horse racing stock entries with the Humboldt county fair as it closes at Ferndale, also will be an exhibitor at the Del Norte fair. Cosgrove will enter his string of stock horses in the Del Norte horseman's show.

Other returning entries include those of Ed Huffman, Edna Plaisted, Mrs. Virginia Stennett, Gary Baker and Mrs. Mabel Maris, all of Del Norte, who will have entries again this year in the floricultural division. Huffman and Mrs. Plaisted, according to Fair Manager McClure, have developed a bit of friendly competition. Both also have entries in the home economics division and in almost every instance are in competition with each other.

Meanwhile, in the chicken and rabbit divisions, expansion of the rabbit show has called for use of a building entirely by the rabbit exhibitors alone.
