School Law Is Clarified

There has been considerable misunderstanding concerning the Compulsory Education Law. In order to clarify this matter the following is offered from the Oregon School Law and the "Summary of the Compulsory Education Law."

In estimating regular attendance, the teacher must consider all absences unless such absences are excused, provided that no excuse shall be accepted by any principal or teacher unless such absence was caused by the pupil's sickness, or by sickness of some member of the pupil's family rendering it impossible for such pupil to attend school.

ANY EIGHT UNEXCUSED ONE HALF DAYS ABSENCE IN ANY FOUR WEEKS PERIOD IN WHICH SCHOOL IS IN SESSION IN THE DISTRICT shall be called irregular attendance.

When such irregular attendance occurs the next step is for the teacher or principal to notify the attendance officer on blanks provided by the State Department of Education.

Upon receiving the notification of "Non Attendance or Truancy" the attendance officer notifies the parent either in person or by registered letter that the pupil shall immediately present himself to school and be punctual and regular in attendance during the remainder of the year.

In case the order to return to school is not promptly complied with, the school is required to again notify the attendance officer. It is the duty of the attendance officer upon receipt of

the notice that the pupil did not return to school, to make a complaint against such parent or guardian of the pupil before the Justice of the Peace.

A parent convicted of failure to comply with the provisions of the act is liable to a fine of not less than \$5.00 or more than \$25.00, or by imprisonment of not less than 2 days or more than 10 days.
