LEGAL NOTICE

NOTICE OF HEARINGS UPON ORGANIZATION OF PROPOSED CURRY COUNTY SOIL CONSERVATION DISTRICT, EMBRACING LAND LYING IN CURRY COUNTY, OREGON.

WHEREAS, on the 24th day of October, 1952, there was duly filed in the office of the State Soil Conservation Committee at Corvallis, Oregon, a petition signed by 61 landowners, pursuant to the provisions of the Soil Conservation Districts Law, Chapter 3, Title 109, O.C.L.A., requesting the establishment of the Curry County Soil Conservation District, and

WHEREAS, the lands described by said petition, and any other lands which will be considered for inclusion in the said district are located in Curry County and described substantially as follows:

All lands located within the boundaries of Curry County.

NOW, THEREFORE, notice is hereby given that public hearings will be held pursuant to the said petition, on the question of the desirability and necessity, in the interest of the general welfare, of the creation of such district; on the question of the appropriate boundaries to be assigned to such district; upon the propriety of the petition, and of all other proceedings taken under the said Act; and upon all questions relevant to such inquiries. The said public hearings will be held by the State Soil Conservation Committee on the 4th day of December, 1952, beginning at 10:00 o'clock, a.m., in the Sixes Grange Hall at Sixes in the County of Curry; on the 4th day of December, 1952, beginning at 8:00 o'clock, p.m., in the Gold Beach County Court Room at Gold Beach in the County of Curry; and on the 5th day of December, 1952, beginning at 1:30 o'clock, p.m., in the Chetco Grange Hall at Harbor in the County of Curry.

Every person, firm, corporation, state, county, or municipal agency holding title to ten acres or more land lying within the limits of the above-described territory, and all other interested parties are invited to attend and will be given opportunity to be heard at the times and places hereinbefore specified.
