The reasons for increasing such levy are:

The necessary expense of operating the school exceeds the tax base of the Rural School District, which is the sum of all the tax bases of all the school districts in the County, except school districts #2CJ and 17C.

The amount of tax, in excess of the six percent limitation proposed to be levied by the rural school district of Curry County, Oregon, for the fiscal year beginning July 1, 1957, is \$215,315.26.

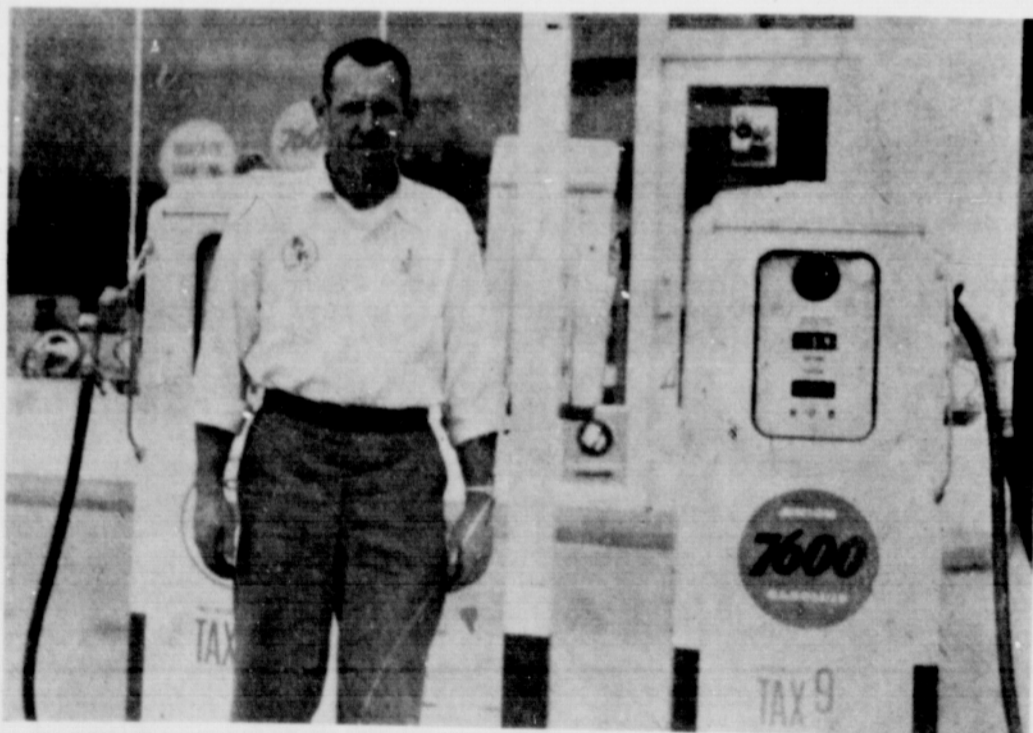
