Revenue Sharing Funds Available

The Siletz Tribal Council receives Revenue Sharing funds from the U.S. Department of Treasury each year. Allocation for the year October 1, 1984 through September 30, 1985 is approximately \$14,000. The Tribal Council budgets these funds based on information received from community meetings held in each of the area offices in Siletz, Salem and Springfield. The preliminary budgeting steps for 1986 are already begun, watch your newsletters for meeting dates and plan on attending and providing your input.

The Tribal Council accepts request for funds from Tribal staff and individual Tribal members and considers them on a case-by-case basis. Many times, a request is received without providing enough information to make a decision. To assist Council in distributing these funds, a form has been developed and printed in this newsletter. Extra forms are available upon request at each area office. If you need help in filling out the form, contact the office nearest you.

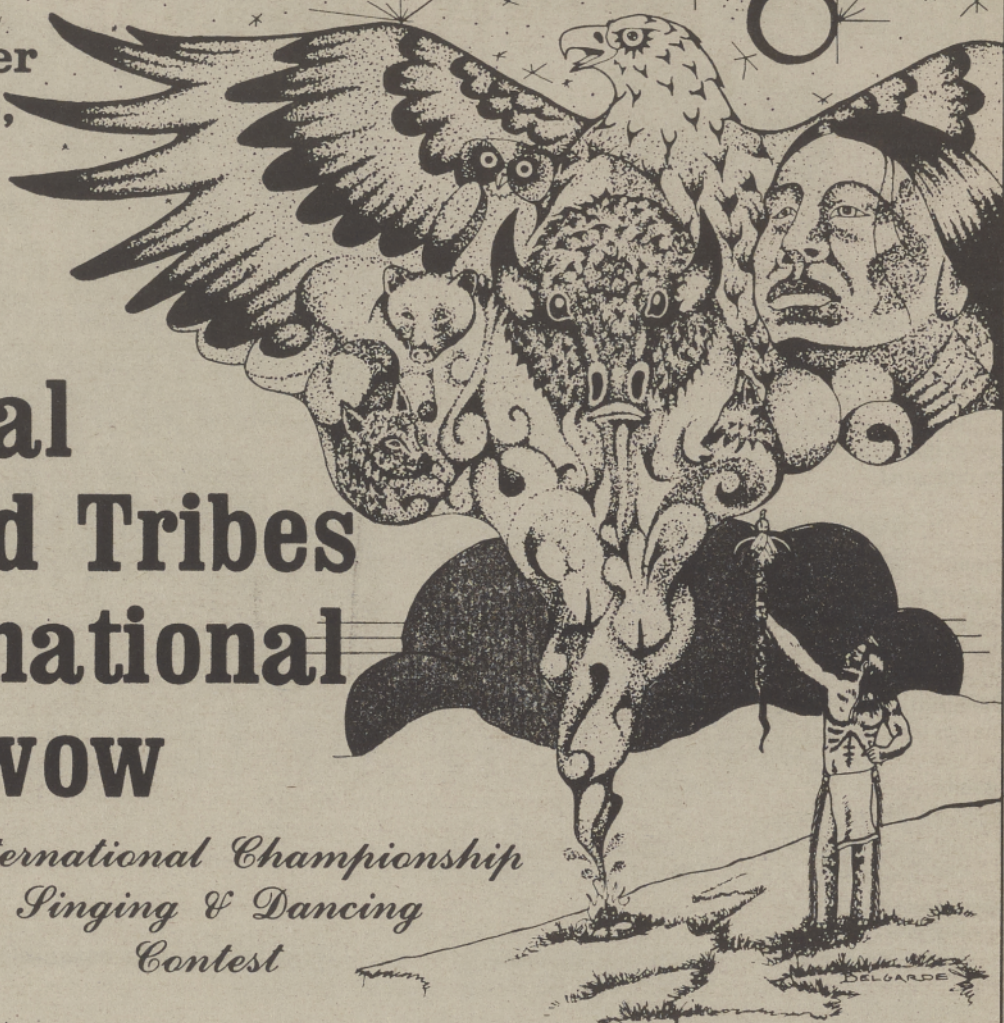
