The Siletz Tribal Economic Development Commission (STEDCO) is working on a plan to operate an evergreen wholesale plant. The purpose is to provide additional revenues to the Tribe and Tribal members who currently pick minor forest products (fern, salal, moss, etc.). The business will also provide some employment at the plant.

STEDCO is recruiting a manager for this enterprise. The ideal person will have a background in business, either by experience or education and will be a person willing to work many hours to see the business succeed. A current understanding of the evergreen wholesale business is **not** necessary to qualify.

Salary for the position will consist of a base rate with bonus incentives. An innovative person with the right background could have the potential to eventually earn as much as \$3,000 per month.
