Local elections timeline changed

Members voted to change SEIU Local 503, OPEU's guidelines on elections at our 2004 General Council. **All local elections must now be completed so that officers are sworn in by May 1.** All terms shall be two years. Local officers elected may include President, Vice President, Secretary-Treasurer, General Council Delegate(s) and Alternate(s), Chief Steward, Steward(s), and Bargaining Delegate(s) and Alternate(s). Locals must inform members about the duties of each office being elected or advise members where they can get this information. Duties and officers elected may vary by local, so each local should check their Constitution and Bylaws. **Most union activities are done on activist's own time.**
