Shall They Be Given Another Chance?

We were impressed with an article in the Portland Telegram by Lois P. Myers, on the kidnaping and slaying of Marion Parker and other like cases. The writer asks timely question: "Who can give another chance to Marion Parker or other mute victims of other slayers?" The court are saturated with the mania of giving young criminals another chance. What for? So they will be at liberty to commit new crime. Edward Hickman was given a new chance, Pender was given a new chance, McClelland, of California, was given a new chance. What was the result? Hickman kidnaped and murdered Marion Parker, Pender, paroled murderer, assaulted a woman, and is now behind the bars for life. McClelland, a paroled convict, is now sought for the kidnaping an eleven year old Oakland, California girl. The record of a majority of the cases, which clemency is granted, show a continuance of a life of crime. The crime for which Edward Hickman was taken, the first time, was punishable by imprisonment, but, he was given another chance, which ended with a fearful climax to his criminal career. We have gone from an age of punishment for crime to an age of sympathy. "One man is too old and another is too young" says the writer, "and a tear drops from the long nose of professional philanthropist while he petitions that this 'poor old man shall not be suffered to spend his few remaining days in the cheerless confinement of a cell'. They are either too old, too young, insane or feeble minded. It is time to call a halt to this sentimental stuff and punish the criminal for his crime.
