Important Occurrences Of The Past Week From Cities In Our State

Death Laid to Doctor.

Bolse.-Responsibility for the death by starvation of Miss Clara Foy, the ther in the public schools of King mil, who died last February, was laid at the door of Dr. Charles C. Smith, the district court at Mountain Home, when it returned a verdict of involuntary manslaughter.

Dr. Smith immediately moved for a new trial which was denied him and then appealed the cast to the supreme court. He was prosecuted by ex-United States Senator K. I. Perky.

OWYHEE MEN ARE INDICTED

J. M. Morgan and D. W. and A. J. Armstrong to Answer Several Charges. Bolse.-J. M. Morgan, D. W. Armstrong and Albert J. Armstrong, wellknown southern Idaho mining men, were arrested here by United States Marshal Hodgin, charged in indictments returned by the last federal grand jury, with conspiring to defraud H. H. Bonnell out of two mining claims he had filed on public land. They were taken before Judge Dietrich and the bonds of each of the Armstrongs was placed at \$1000 while that of Morgan was fixed at \$2500.

The true bills charge that on August 20 of last year the three men connived to deprive Bonnell of his civil rights by appearing in the land office in this city and filing a homestead on Bonsell's mining claims.

Merticultural School Appreciated at Lewiston.

Lewiston.-There is now little excuse for complaint by the fruit growers of eastern Washington for not knowing the practical modern methods of fruit growing, with the inauguration of the Lewiston-Clarkston horticultural school, which offers to all fruitmen of that locality a six weeks' course in the raising of better fruit and cultivation of better orchards.

The school is unique in that it gives grownup fruit growers, in a narrow space of time a clear view of what can be done under the tutelage of practical fruit men. The school is intended to be practical in every sense, eliminating as much of the theoretical phase of fruit growing as will give them a working knowledge of the business.

SNOWSLIDE KILLS CARRIER

P. E. Endicott Caught by Avalanche Between Rocky Bar and Atlanta.

Twin Springs .- P. E. Endicott, mail carrier between Rocky Bar and Atlanta, lost his life in a snowslide while on his way to Atlanta. His body was recovered, being uncovered by a party of searchers digging in the snow for

The mail carrier left Rocky Bar on one of his regular trips. He was bound for Atlanta but did not reach a little cabin on the summit of the mountain where he was accustomed to meet Mail Carrier Jones, coming from the opposite direction, at night. Although Mr. Jones was alarmed,

he was unable to make any investigation that night, but remained at the cabin on the summit. Next day he started to go over the route to search for his fellow-carrier and encountered the huge slide, which extends over a

great distance. Tracks of Endicott were clearly discernible in the snow. They led up to the edge of the slide, where they were

obliterated. Mr. Jones hurried to Atlanta and a search party at once started over the mountain. After several hours' hard digging Endicott's body was uncovered. It was buried under three and a half feet of snow.
