The Russian forces have seized a German steamer at Vladivostok.

Montenegro has decided to cast her

Sweden, Norway, Belgium and Holfand imitate Italy's example by maintaining neutrality.

Communication between the nations of Europe except by the governments, has ceased. England is isolated by the severance of all wire connection with the continent.

Germany's declaration of war against Russia has provoked in the Russian capital a wonderful demonatration of patriotic enthusiasm.

The Servian war office admits the Servian army has retired before the Austrian advance on the Bosnian frontier and along the southern bank of the Drina.

The approaching general European clash may involve more than 31,000,-000 men.

Trans-Atlantic traffic between New York and Europe is virtually suspended. One hundred and fifty thousand Americans in Europe face the possibility of being marooned indefinitely.

A German spy caught photographing the Portsmouth harbor in England and two spies at Southampton have been arrested.

Japan assembled her fleet at Sasebo, but little likelihood of Japan being embroiled unless British ships or possessions in the far east are attacked.

Financially, Germany is well prepared for war. Within a week the kaiser will have at hand at least \$370,-000,000 in gold and silver for the vast expenditures immediately necessary.

Italy by proclaiming neutrality, has virtually separated from Germany and Austria, her partners in the triple alliance, although she has put part of her troops under arms. She will fight | the North sea.

It was reported that Germany and Turkey have arrived at an understand-PUBLISHED EVERY THURSDAY ing whereby Turkey is to attack Servia from the rear. If this is true, then the Balkan nations must come to the aid of Servia.

With the receipt of the news that Germany had declared war against Russia orders were immediately issued from the war office for a hurried movement of troops toward the Belgian border. Located as she is, Belgium plans to guard her frontier to prevent the centering of the fighting between German and French armies falling on Belgium soil.

The feeling against Germany throughout all of Great Britain is most intense. Anti-German demonstrations have already taken place in the West End of London. Police quelled a near riot of Frenchmen at the German embassy. The police have controlled all demonstrators up to the present, but it is feared there may be real trouble in the provinces before the Germans there can flee the coun-

William F. Massey, prime minister of New Zealand, has announced to parliament that the government proposed to offer the services of an expeditionary force to the imperial government if events necessitated.

AMERICANS 'BROKE' IN PARIS

Ambassador Herrick Wants Gold

Rushed By a Cruiser. Paris.-The situation of Americans on account of the war crisis is bad. Their panic was increased by the closing of banks, Cooks' agency and American Express. The inability to secure money is the chief peril of the Americans, for there will be plenty of trains to boats after mobilization is over.

Ambassador Herrick, however, considers the financial situation se critical, it is reported, he will ask Washington to send a swift cruiser with cargo of gold to enable Americans to cash their checks, at present useless. He also will ask for transports to facilitate getting out of the country.

The most unfortunate part of the situation is the fact that such a great number of American women are here alone. Several hundred are in the embassy. The majority of Americans at the embassy are refugees from Germany and Austria.
