Verdict In Arson Case "Not Guilty." Portland. - "Not guilty," was the verdict returned by the jury in the case of Max Albert, charged with arson, whose trial was concluded in Judge Morrow's department of the Circuit Court. The trial was the first of a series of prosecutions of members of the alleged "arson trust," in which it was expected to show illegal activities of a group of Portland shopkeepers to defraud insurance companies. Indictments charging arson were returned by the August grand jury that involved nearly a dozen small merchants and one local attorney, David Pepp, who is charged with having

STATE TO LEASE LAKES

Land Board Will Receive Bids for Minerals In Water.

Salem.-The state land board fixed December 10 as the time for receiving bids for the lease of Summer and Albert lakes, which have value on account of mineral deposits contained in publication of this summons is on Sept. the water.

BELGIANS REGAIN TERRITORY

Victory at Oortenberg Sald to Cut German Army in Two Sections. London.-An Ostend dispatch to the Exchange Telegraph company says:

"The Belgian troops have just gained an important success at Oortenberg, between Louvain and Brussels, cutting up a German corps and taking several prisoners. The line toward Liege has been occupied by the Belglans." The Belgian victory at Oortenberg

is regarded as especially important, as the German army occupying Belgium has been cut in two sections as a result of it. The victory was due in great part to artillery of heavy caliber which was used for the first time

The Belgian legation announced that the Belgians had again taken the offensive, which was being pushed satisfactorily. Malines and Aerschot were retaken. The Belgian legation said Belgians had destroyed the milway between Louvain and Tirlemont thus cutting off the German communications between Brussels and Liege.
