The climate feature of this section of eastern Oregon during the winter season compare favorably with points in California that are heralded as the only desirable locality for easterners to locate. While Ontario and its surrounding country bask in a sunshine of warmth, with no prevailing winds, rain or snow, the Pacific coast towns are grumbling over weather conditions. We are surely living in the banana belt of the great Northwest, and only enough cold weather prevails to give us a little pep and ginger for the coming spring and summer campaigns of activity.

That the United States will be in a position of leadership in the trade and finance of the world, at the end of the war in Europe, is the growing conviction of all students of the situation. It is the opinion of the New York Commercial that at the present rate "the United States will have all the money in sight and will stand in the position of creditor to the rest of the world." This, the Commercial says, will give us a wide opportunity and a heavy responsibility.

The latest "dream" is that Mr. Ford will next year make 1,000,000 cars and that they will sell for

\$111.85. The \$100.00 is to cover the cost of manufacture, \$1.00 is taken for profit by Mr. Ford and \$10.00 is for the middlemen. The \$5 cents is possibly to make up for conducting a peace ship to Europe.

#### NOTICE!

In the recent convention of county school superintendents, the State Department of Education instructed the county superintendents to call attention to the following extracts from the School Laws of Oregon. Teachers school boards and superintendents throughout the state will hereafter meet all of these requirements:

#### Section 84, Page 44 of the 1915 Oregon School Laws. Teachers Must File Certificate and Contract.

The county superintendent shall require teachers before beginning to teach in any school district in his county to register in his office, if they have not previously done so, their county certificates or state papers, and file a copy of their contracts, and should any teacher fail so to register his or her certificate or State paper, and file a copy of his or her contract in the office of the county school superintendent before beginning to teach in any district in his county, said teacher shall forfeit to the said district the full amount of salary for the time taught before said certificate, or State paper, or contract were so filed. The county school superintendent shall notify the

clerk of said district of the amount of such forfeiture and shall deduct the amount of said forfeiture from the next apportionment due said school district. The requirements of this section shall be enforced only by the county school superintendent of the county in which the school building in which the teacher is employed shall be situated.

#### Section 24, Page 19 of the 1915 Oregon School Laws. Registration of Certificates.

1. All certificates issued by the Superintendent of Public Instruction shall be valid and entitle the holder thereof to teach in any district in a county until the county superintendent has satisfied himself that the applicant has done the reading circle work prescribed by the state superintendent of public instruction for the teachers of the state for the previous year and such registration shall entitle said teacher to teach in said county; provided, that the registration and reading circle work required in this subdivision shall not apply to districts of the first class; provided, further, that it is hereby made the duty of the Superintendent of Public Instruction to prepare a teachers' reading circle course for teachers as provided for in this section and also to formulate rules and regulations governing the same.

Section 101, Page 51 of the Oregon School Laws. State Certificate and Diploma Must Be Endorsed—Fee.

(11. No warrant upon the common school fund shall be given in favor of any teacher holding a state certificate or diploma, unless such certificate or diploma show an endorsement signed by the county superintendent that it has been registered in his office, as required by law.)

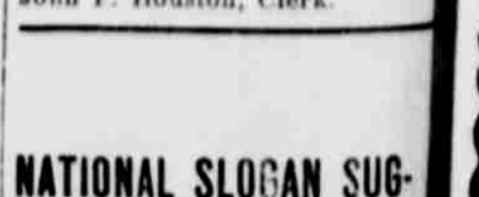
