#### THE TREND TO HUGHES.

The one outstanding feature of the last week of the present national campaign has been the trend to Hughes on the part of influential publications. Among the nationally known organs to come out for the republican candidate are Collier's Weekly and The Chicago Daily News. Of local significance was the switch of the Boise Capital News, like its Chicago contemporary, a democratic paper, from Wilson to Hughes.

There is a reason for this. Publications of the character of those named above do not play fast and loose with their political opinions. Their decision was reached only after mature consideration; after the evidence was all in.

One and all of these publications pronounce Mr. Wilson as an unsafe man; one whose vacillating policies spells both ruin at home and dishonor abroad.

At this late hour in the campaign it may be useless to review the record of the administration but can the voters of Malheur county by their ballots next Tuesday endorse as American, the man who has so debased our citizenship, who nullified the civil service laws:

The man who denied American citizens protection on the high seas: The man who abandoned Americans in Mexico and left them to be saved by British and German warships:

The man who surrendered the rights of 100,000,000 Americans at the behest of four labor unions in return for their votes:

The man who has made the name American a term of derision in every civilized land:

The man who refused to uphold the rights of neutral nations when the crisis came:

The man who one day was for preparedness and the next day against it:

The man who one day was for free trade and a few weeks afterward advocated and signed a protective measure:

The man who one day condemned labor unions and declare "I am a fierce partisan of the open shop," and now in a political campaign becomes a walking delegate for four labor organizations at the expense of the farmers and business men of the nation:

The man who signed the bills cre-

ating 33,000 additional federal positions and nullified the civil service laws to fill the offices thus created by the spoils system:

The man who, as Owen Winter has eloquently said: "Filled the American eagle so full of white feathers that the bird cannot tell himself from a gander."

Will the voters of Malheur county place the stamp of their approval on such a man? They will not if they but stop and consider the record.

#### FARMERS' CREDIT RUINED.

The most disastrous thing that could happen to a business man would be the ruination of his credit. With his credit gone, the average business man would be bankrupt. Anyone who ever had any business experience in the business world knows that.

What is true of a business man is equally true of a farmer. It is especially true of a farmer in such a county as Malheur. Everyone knows that it takes money to develop an irrigated farm. It takes large quantities of money. Everyone who knows anything, also knows that the one thing that has held back the development of Malheur county is the very lack of money.

Within a few months, January 1, to be exact, the federal rural credits banks are to be launched. These banks are to furnish the money needed for the development of the ranches of the country. They are to supply on long time, low interest rates the thing which the farmers' unions, granges and farmers generally have been working and praying for years.

But, and here's the rub, these banks will loan only a sum equal to one half of the assessed valuation of the land covered by the mortgages which secure the loan. Notice, one half the assessed valuation is the limit that can be borrowed; and, no doubt only the best of land will be able to get that much. Of what use, practically speaking, would a loan of \$7.50 per acre be to a man on Dead Ox Flat; or \$10 per acre on the Shoestring? Yet that is all that would be available, provided they could get the very highest amount possible under the law.

The low valuation placed by the present assessor is the most deceiving act imaginable. Why not a single cent will be saved a single taxpayer—except the favored ones whose valuations, as they themselves know,

are ridiculously low. The gross amount of money to be raised will be just the same. The only difference will be that the levy will be high. The farmer will pay just as much cash, and his credit will be ruined for all practical purposes so far as the rural credit banks are concerned.

If only the ranchers will think of this phase of the situation there will be no danger of having such a condition repeated. They will realize that the man who thus served them is their worst enemy. No one could have served them worse for by his action he has removed the foundation of substantial progress for some time at least.

#### MRS. CONKLIN FOR SUPERINTENDENT.

The voters of Malheur county will have an excellent opportunity to place an energetic and competent woman in the office of county school superintendent next Tuesday in the person of Estella Conklin.

Despite of her handicap in getting into the campaign; for she has remained quietly at her work in the school over which she presides, the desire for her election has made steady progress. To the people of this vicinity, who know her, Mrs. Conklin needs no words of praise. Her record and her abilities are sufficient to warrant the support of every voter.

Mrs. Conklin is a native Oregonian. She was born in Union county and

after her graduation from the Month normal school taught in Union county for four years. On the authority of the superintendent of one of the largest school systems in this state, who is acquainted with her work in Union county the Argus is glad to say that she was an excellent teacher, a capable manager and was universally esteemed by the pupils and patrons of the school there. From her friends here the same recommendation is received.

Mrs. Conklin, too, has been a resident of Malheur county for many years, eleven to be exact, and during this time has been connected, directly and indirectly all the time in the educational problems of this section. She is therefore in a peculiar manner equipped to perform the duties of the office to which she aspires. #### SETTLE THE LIQUOR QUESTION.

The voters of Oregon might just as well settle the liquor question for all time next Tuesday. There is no doubt concerning the attitude of the majority of the voters. There is no desire for a return to the old license system in any form. The saloon is an institution which will never raise its head again in Oregon. To settle this question for all time the voters must register their verdict on two

measures next Tuesday, Nos. 315 and 316.

To make Oregon genuinely dry the vote on these measures should be 315 X No., and 316 X Yes.

It is the almost unanimous opinion of every business man in every community that the abolition of the saloons has been a distinct benefit to them. There have been fewer accounts unpaid. There have been fewer arrests for petty crimes. The record is almost beyond belief. There is no argument that can be advanced for the liquor traffic. No man ever benefited by the use of intoxicating liquor, and certain it is that thou-

sands upon thousands have suffered untold misery and privation from it.

The judgment of society throughout the world is that its baneful influence is a detriment to the human race. Its abolition will not prove a panacea for all the ills of mankind, however, the voters of Oregon will no doubt register their approval of the present law and demonstrate that they will not permit the commonwealth to lose a step in the march of progress by voting against the brewery amendment and in favor of the constitutional amendment making Oregon really dry.
