## POMONA GRANGE WILL DISCUSS ROAD BONDS

Senator Hurley, District Attorney Swagler and Supt. E. G. Bailey Among Speakers—Food Supply to be Considered.

Saturday, April 21st, is Pomona Grange Day for Malheur County. The meeting will be held at Arcadia School House. A big meeting is expected for many important things are to be discussed on that day.

The big feature of the day will be a discussion of the proposed road bond issue of \$6,000,000 to be voted upon June 4th. There is general ignorance concerning this law. Many who say they will vote against it know nothing about it, and fully as many who say they will vote for it know just as little. It is an important question, and everyone should make a great effort to be present. State Senator Hurley of Vale will discuss the law from the supporters side and other speakers will take the opposite side of the question.

The national food supply question, because of our Nation being at war is another feature of the program. The Secretary of Agriculture, Huston has stated that the world is facing a serious famine. Parts of our own country are in danger because of the poor condition of fall sown grain and the shortage of labor and of high price of seed. Come and help solve this problem.

### PLEA OF GUILTY MADE IN THE SEAWEARD CASE

Ontario's delegation of attorneys returned last Friday from Burns where Judge Dalton Biggs presided over the spring term of court. Among the legal lights from Ontario who attended the term were J. W. McCulloch, W. W. Wood, P. J. Gallagher and W. H. Brooke.

Considerable interest centered in the cattle larceny cases of Pickett and Seaward. The former case was tried first the jury disagreeing. In the latter case a plea of former jeopardy was entered and after this was argued before the jury and decided adversely to the defendant Ben Seaward entered a plea of guilty, on which he was given an indeterminate sentence. According to reports coming from Burns this ends the cases against the Seaward boys, who are described as the victims of "higher-ups," whose turns in court are expected to develop sensational disclosures.
