How to Brush Teeth

MOST Tooth-brushing is done very thoughtlessly. It does not remove food deposits from all the surfaces of the teeth and the mouth.

The tooth-brush must not be too coarse and stiff, and it should be drawn straight across the teeth. The proper method is to brush from the gum-tissue toward the cutting edge of the teeth with a slight circular motion.
