PETITION OF THE BOARD OF DIRECTORS OF THE PAYETTE-OREGON SLOPE IRRIGATION DISTRICT praying that the proceedings of the said Board and of the said District providing for and authorizing the issue of six per cent bonds of the District in the amount of Fifty Thousand (\$50,000.00) Dollars for the purpose of meeting the deficit in maintenance for the year 1918, meeting the cost of enlarging the ditches and dredging the intake canal, and to provide funds for the purchase of a new pumping unit to supplement the existing pumping machinery of the District, may be examined, approved and confirmed by the court above entitled.

To the Payette-Oregon Slope Irrigation District, an irrigation district and municipal corporation located wholly within Malheur County, Oregon, and organized and existing under the laws of the State of Oregon, and to all freeholders, legal voters and assessment payers within said District and all persons interested in the organization of said District or in said District or in the special proceedings above entitled, pending in the above entitled court, or in the proceedings for the issuance or sale or use of the bonds of said District more particularly hereinafter described, and to all persons whomsoever, and to you and each of you:

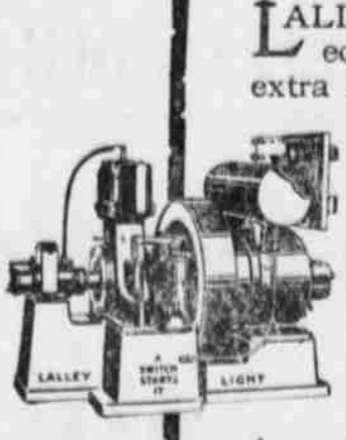
