## PAVING TO BRIDGE RECALLS FIGHT MADE FOR CONSTRUCTION

After condemnation proceedings had been had to secure the final stretch of right-of-way for the road that is now paved, work was started. In places the road was so swampy that five and six feet of gravel was used to make it passable.

The commission was badly handicapped. It had used a larger portion of its funds than it had planned on the right of way on the eastside and in making the cut. However it completed the task, and on November 16th 1909 reported to the city council, which was then headed by Dr. G. A. Pogue, as Mayor, that its work was completed.

In connection with the securing of the appropriation and keeping the funds City Attorney A. N. Soliss played a prominent part. The original state appropriation carried the usual 90 day clause, and Ontario men learned that one L. H. McMahon of Salem intended to enjoin the state officials from issuing the state warrant, so Mr. Soliss made a trip to Salem, reached the office of the State Treasurer at 8 o'clock in the morning of the last day, secured the warrant and cashed it at a Salem bank and then sent the funds to Ontario. McMahon did not quit then. He came over here to see the County Court to enjoin it from issuing a warrant, but again was forestalled by the vigilance of the bridge commissioners.

What this bridge has meant to Ontario only the business men realize fully. But it has been of equal advantage to the people of the Fruitland bench and of Idaho for it has given them what they otherwise would not have had; two trading centers, two towns to go to enjoy themselves and take advantages such as towns afford, and that they have appreciated this, Ontario realizes. For this appreciation Ontario is grateful and in celebrating this final step in cementing the bonds of friendship invites everyone in the valley to be the guests of the city on Monday, November 1.
