Boys and Girls Active

Very definite progress was made by the Club department of the Bureau. There were 14 sewing clubs with 106 girls working; two cookery clubs and four individuals or 23 girls working; four boys did potato club work;9 boys did corn club work; 14 boys and girls raised pigs;altogether there were 164 children who enrolled for some form of club work. and 150 of them sent in completed reports. 
