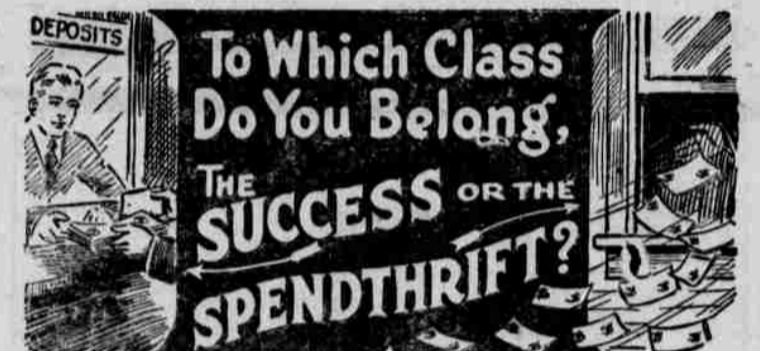
BIDS FOR TRANSPORTATION OF PUPILS
