1916 Delinquent Tax List for Malheur County, Oregon

The following list of real property is hereby advertised for delinquent taxes as assessed for the year 1916.

This advertisement is authorized by an act embodied in Chapter 601 of the General Laws of Oregon, as passed by the 1913 session of the Legislature.

Taxes on the following list of property became delinquent October 15th, 1917, and the subject to a penalty of 5 per cent after November 15th, 1917, and interest at the rate of 1 per cent per month until paid.

Six months after such taxes are delinquent, Certificates of Delinquency, bearing interest at the rate of 12 per cent per annum will be issued thereon.

Any time after the expiration of 3 years from the first date of delinquency of any tax included in a certificate of delinquency the holder of such certificate may apply to the Circuit Court for a decree foreclosing the lien against the property mentioned in the certificate.
