The hens should be dusted with a good insect powder. Many of the powders that are sold are no better than dry earth, having lost most of their efficiency. You can make a good lice powder by taking three parts gasoline and one part crude carbolic and mixing it with plaster of paris. Put a little of the liquid on to the plaster of paris and mix thoroughly till it is dry. Then apply to the feathers of the hens.


