CITY NEVER HAS PAID THE TAXES

A few Errors in an Article Last Week Are Now Corrected.

Our attention has been drawn to one or two errors which inadvertently crept into the write-up of the Mt. Scott Park in our last issue. We are glad to correct them. In the first place the city never has paid the taxes on these lots which are used as a park and donated by the owners; the owners themselves have always paid the taxes as well as donating the use of the ground, the city has merely installed the equipment and supplied park directors. This year the taxes are so heavy that one or two of the property owners have protested against the added burden and have suggested that it would be only fair for the city or those local residents who get the advantage of the park to stand some of the taxes. One property owner is taxed this year \$58. He is willing to pay part but suggests that someone else who gets benefit from the use of the park should pay the balance, surely a modest request. We also learn that another property owner in the Corvallis tract is Mrs. Lucia Faxon Additon. Her holdings do not at present come within the park limits, however, but when the park is extended will be included, with out doubt.

It seems to be clear at the present writing that the city will not close the park, and probably not even move its location at all. It is hoped that they may help somewhat in the payment of the taxes also.

with money, and he got busy protecting his bank from every possible contingency or strain. He got hold of each big depositor and found out how much money he would need and how much money he would leave in the bank. Among the big depositors was the sheep buyer, to whose credit was \$54,000. But the buyer insisted he only had on deposit \$1,000. He checked up his account with Thompson, and found that Lee's check for \$53,000 had not been presented. And it didn't come in for weeks. Lee's explanation was original.

"I smelt a panic," he told the sheep buyer, "and I thought I would hang onto this check until it was over, for I knew Bill Thompson and he knew I was taking no chances." He didn't lose the check. He carried it next to his underclothes.

Lee was in Portland the other day. He discussed the affairs of the day with insight and sagacity. He is patriotic to the core, a heavy buyer of Liberty bonds, liberal subscriber to the Red Cross and ready to do everything that producing ability can do to help his country to win the war, whether his contributions be cash, wool or mutton. And in the course of intensely interesting conversation he told the reasons why he subscribed \$5,000 to the Stanfield campaign fund.

"I first began to deal with Bob in 1906," he said. "I have had many business dealings since. I always found him on the square. He was a man of his word, and he never drove a sharp bargain, was always willing and anxious to see that the producer made money and was encouraged. I discovered that he was a big man, a very big man, although he was only a boy in years. I watched him develop. He and I talked over public affairs, and I found that his ideas were farsighted and patriotic, that he had a common sense view of public questions, and that he was always for the under dog." I also found that he was working steadily for the upbuilding of live stock and agriculture. My admiration for him grew. I finally regarded him as the finest character I had ever known as well as the ablest man. I was tremendously pleased when he announced he would run for United States Senate. The country needs a man of his character and his ability. We are at war and the problems are big. Stanfield has the brain and the moral courage. I knew the character of the man and knew that if the people generally could be made to know more about him he would be elected. I knew it would take a big campaign to stir the people up. So I sent my check for \$5,000 to help the campaign and I feel that I never parted with any money that would do more good to our country and state. Bob is so honest and square and able that he will do a power of good in the senate. He is the kind of a man that is needed there, especially in times like these. And if more money is needed to help spread information about him I've still got my checkbook."

We have heard of a number of other contributions made by rough-handed, weatherbeaten men of the range, men with whom Stanfield has dealt for years, and who have become so impressed by his character and ability that they fairly idolize him. If this is how the campaign fund is subscribed, it will be unique in the history of political campaigns in Oregon.
