Call For Democratic Primaries and Conventions.

Pursuant to the call of George Fitzhugh, Secretary of the Democratic Central Committee, the Committee met at Gold Beach, Curry county, Oregon, Feb. 15, 1902. And in absence of chairman and secretary, Dennis Cunniff, Sr., committee man for Gold Beach precinct, took the chair, and B. Guthridge, by R. E. Guthridge, proxy, secretary.

On motion, it was decided that the Democratic primary elections be held in each precinct of the county, at 1 o'clock P. M., on Thursday the 27th day of March, and that the Democratic County Convention be held at 10 o'clock, A. M., on Thursday, the 3d day of April, 1902, at the court house in Gold Beach.

It was decided that the apportionment of delegates to the Convention be as follows: One delegate at large from each precinct, and one delegate for each ten votes, or fraction over half of ten votes, cast for Thomas G. Green for Supreme Judge at the State election held in June, 1900, to-wit:

- Chetco, 3; Mountain, 1; Pistol River, 2; Gold Beach, 2; Wedderburn, 2; Ophir, 1; Port Orford, 3; Sixes, 3; Floras Creek, 5; Eckley, 3; Mule Creek, 2; Big Bend, 3; Quasaten, 1; Jerrys Flat, 2.
- On motion, meeting adjourned.

The time for its delivery is not fixed.

Initiative and Referendum.

At the coming June election the people of the State of Oregon are to decide a very important matter. They will by their votes either adopt or reject a Constitutional Amendment embodying the initiative and referendum in what may be termed a mild form.

The two last legislatures voted to submit the proposed amendment to the suffrages of the people and at polls.

There has been organized the Direct Legislation League of Oregon, whose avowed object is "the adoption by the people of the initiative and referendum amendment to the Constitution of the state of Oregon at the general election in June, 1902."

The proposed amendment is short and easily understood:
Section 1 of article IV of the Constitution of the State of Oregon shall be and is hereby amended to read as follows:

Section 1. The legislative authority of the state shall be vested in a legislative assembly, consisting of a senate and house of representatives, but the people reserve to themselves power to propose laws and amendments to the constitution, and to enact or reject the same at the polls independent of the legislative assembly, and also reserve power at their own option to approve or reject at the polls any act of the legislative assembly. The first power reserved by the people is the initiative, and not more than eight per cent of the legal voters shall be required to propose any measure by such petition, and every such petition shall include the full text of the measure so proposed. Initiative petitions shall be filed with the secretary of state not less than four months before the election at which they are to be voted upon. The second power is the referendum and it may be ordered (except as to laws necessary for the immediate preservation of the public peace, health or safety), either by petition signed by five per cent of the legal voters, or by the legislative assembly as other bills are enacted. Referendum petitions shall be filed with the secretary of the state not more than ninety days after the final adjournment of the session of the legislative assembly which passed the bill in which the referendum is demanded. The veto power of the Governor shall not extend to measures referred to the people. All elections and measures referred to the people of the state shall be had at the biennial regular general elections, except when the legislative assembly shall order a special election. Any measure referred to the people shall take effect and become the law when it is approved by a majority of the votes cast thereon, and not otherwise. The style of all bills shall be: "Be it enacted by the people of the State of Oregon."

This section shall not be construed to deprive any member of the legislative assembly of the right to introduce any measure. The whole number of votes cast for justice of the supreme court at the regular election last preceding the filing of any petition for the initiative or for the referendum shall be the basis on which the number of legal voters necessary to sign such petition shall be counted. Petitions and orders for the initiative and for the referendum shall be filed with the secretary of state, and in submitting the same to the people he and all other officers shall be guided by the general laws and the act submitting this amendment until legislation shall be especially provided therefor.

Prince Henry on America.

Prince Henry is credited in the dispatches with having said some very nice things about the American people on his arrival in the fatherland. When asked what had impressed him most forcibly during his trip he promptly replied that the great, orderly and cheerful crowds had been his most continuous impression, and would always remain his most vivid recollection. "I saw crowds out of doors and indoors," he continued; "faces of men and women, with here and there a powerful, a beautiful or a spiritual face. My regret, if I dared to say I had any, was that I could not know some of these people better."

Commenting upon his royal impression, The Philadelphia Record says: "Here is a personage bred in the school of royalty, inculcated with the doctrines of the divine right of kings and with the negation of the principle of democratic equality, and one to whom the sight of the multitudinous on the public highway and in assembly halls was not new. Yet, when he put his foot on American soil and looked into American faces some of them 'powerful, beautiful or spiritual,' he received the ineffable impression that the superlative fact in the United States—the thing beside which everything in America vanished into insignificance—is the great orderly, cheerful crowd; in a word, the American people."

Cape Town, March 26.—Cecil Rhodes died peacefully at 5:57 p. m. He slept during the afternoon but his breath became difficult and his strength perceptibly diminished until he passed away. His death came as no great surprise to those who saw anything of him the past few months. Whether it was due to his experience during the long siege of Kimberley or the accumulated anxieties regarding the war in South Africa, with an accompanying change of public feeling in England toward him, there is no doubt he was almost completely broken down within the past two years.

Washington, March 25.—Major-General E. S. Otis closed his active career in the Army today by reasons of age, and will go into retirement. He will be succeeded in command of the Department of the Lakes at Chicago by Major General MacArthur.

The Department has paid an unusual tribute to General Otis in issuing a general order reciting the distinguished services of the officer, not only through the Civil War, but in his management at Manila. In conclusion Secretary Root says: "General Otis goes into his retirement with a consciousness of duty well done during 40 years of continuous and exceptionally meritorious service, which entitles him to the gratitude and best wishes of his countrymen."

Des Moines, Ia., March 25.—The House today passed, by a vote of 67 to 15, a joint resolution asking Congress to call a National Convention in accordance with the provisions of articles 5 of the Constitution, with a view to bringing about the election of United States Senators by popular vote.

Canadian Giant.

Dame nature has apparently outdone herself in Edward Beaupre, the young French-Canadian giant, who bids fair to outrival the fabled one-eyed giant Polyhemus of Homer's time, while he outtops by several feet modern competitors.

Beaupre therefore enjoys the proud distinction of being the tallest man on earth. He is 30 years old and tips the scales at 587 pounds and stands 10 feet 11 inches high, his hands measuring 19 inches and his feet 24 inches by 12 wide. A two-yard tape measure barely encircles his chest.

Each of his trousers legs can contain the figures of ordinary persons, and there is sufficient cloth in one of his suits to outfit ten average men. The massive framework of each of his out stretched arms will bear the weight of three athletes. A man 5 feet 10 inches by his side appears a mere pigmy.

One of the peculiarities about Beaupre is that his father and mother were of ordinary size. From his youth he has been a great gymnast, and has given much time to athletic sports.—New York Herald.
