The proposed Initiative and Referendum amendment to the Constitution of Oregon has been endorsed and recommended to the people by the Republican state convention, the Democratic state convention and the Socialist party convention.

A Costly War.

The Boer war into which Great Britain entered with such cheerfulness and alacrity and with the expectation that it would be finished up within four months has proved one of the most expensive in which that empire has been engaged.

When three years ago the British government entered upon this war it not only fixed a limit of four months for wiping out the Dutch republics but was confident 47,000 men would be ample for the work and that the whole outlay would not be over \$49,000,000.

The cost in life and in suffering has been still more extraordinary. The Boer loss is not accurately known, but the mortality in the prison camps, added to that in the field has been large.

And when the war is over and the last Boer has been subjugated, then must follow years of difficult and expensive administration before the South African country can recover from the ravages of war and enjoy even a reasonable degree of prosperity.

The Pacific Cable.

The laying of the trans-Pacific cable is now assured. It will complete the telegraphic circuit of the globe.

The cable is being manufactured in this country and will be laid by skilled American electricians and engineers. It will be the longest submarine cable in the world, extending 8,000 miles, from San Francisco to Manila, touching at Honolulu and Guam.

The Pacific cable will have connections with a line to China and Japan thereby establishing direct communication from America to those countries. At present all messages have been sent by way of Europe.

With the addition of this new link in the world's great mileage of submarine cables their united length will more than girdle the earth eight times, or reach two thirds of the way to the moon.

The United States steamship Nero, especially equipped for deep sea explorations, has mapped out the pathway for the cable, having made nearly 1000 soundings.

The cable line from California to the Hawaiian Islands is to be in operation within nine months, and the whole line will be completed within two years.

From those close in touch with the Boer leaders in The Hague it appears that the latest secret dispatches from south Africa outline the peace proposals now under discussion at Pretoria.

The boers accept a British lord commissioner with a boer executive, both to be resident at Pretoria.

The country to be divided into districts, with British district officers, the majority of whom must speak Dutch, and a boer committee chosen by polling by the burghers. The veto right is to be reserved to the British government.

Jonannesburg to be restored to the British civil government.

A war indemnity of at least \$50,000,000 to be distributed by mixed committees.

Disarmament to occur when the first batch of boer prisoners is sent back to south Africa.

No war tax to be levied. Both languages to be recognized in the schools and courts and in official documents.

The expense of the garrisons in south Africa to be borne by Great Britain.

The present boer leaders to be retained in office so far as possible.

Arrangements have been completed for the formation of a gigantic rival to the United States Steel Corporation. The new company will be incorporated in Trenton, N. J., and will have a capital of \$200,000,000.

According to the press dispatches the season's estimated clean-up of gold for the Dawson district is \$30,000,000, a larger amount than has been produced in any preceding year.
