Shipwreck at Cape Blanco.
Steamer South Portland Strikes on a rock and Sinks.
21 persons missing.
Capt. McIntire Among First To Leave the Ship.
The steamer South Portland, bound from Portland, Oregon, to San Francisco, with a cargo of wheat, struck on a rock in the vicinity of Cape Blanco, (exact locality not known) during a heavy fog about 5 o'clock last Monday evening, Oct. 19.
The first information of the disaster received here was the arrival of a life boat at six o'clock yesterday morning, containing Captain McIntire, the master of the ship, Manoel Patsomis, chief cook, John Bremer, sailor, and Wm. L. Wilson, Leslie Baker, Guy Bent, and Al. Railey, passengers. Guy Bent is a little boy aged 7 or 8 years, whose mother if among the missing. This boat left the ship with seventeen on board according to the statement of the chief cook, was twice capsized, and but seven reached shore in her. About eight o'clock yesterday morning Dave McKenzie brought the news that a raft with people on board was drifting off the mouth of Elk River. The ship's life boat, was quickly manned with Chas. Crew in charge, and about 12 o'clock brought in the raft with ten survivors and one dead body, the first assistant engineer having died after the boat reached there.
Another raft containing nine persons is known to have left the ship, but has not been sighted up to the time of going to press. A tug from Coos Bay is supposed to be out in search of survivors. The Bandon life-saving crew arrived in Port Orford last evening overland but after a short cruise returned for the night.
According to the best information obtainable there are twenty-one persons now missing, including two lady passengers. Of these nine were on the missing raft, and if they have not by this time reached shore or been rescued they have evidently perished with cold and exhaustion, while the others are all lost without a doubt.
There is a discrepancy as to the time the ship went down after striking. The lifeboat, containing Captain McIntire was the first to leave the ship, and the first to reach shore. The Captain immediately retired, while the others gave such information as they could. Two of these men returned in the life boat in search of the raft, while the ship sank within a half hour. Those on board the raft did not leave the ship until long after Captain McIntire took to the boat. They think it was about one and a half hours from time of striking before she went down. Of course, Captain McIntire being with those who first left the ship, and lost out in the fog, was not in a position to note definitely the intervening time between the striking and sinking of the ship.
Captain McIntire on being approached for information regarding the disaster, was very reticent—very curtly remarked that he had mailed his report to the proper parties, and had no information to give,—leading to the conclusion that it was Capt. McIntire's belief that it was nobody's business but his own and his employer; none of the business of the people of Port Orford and vicinity how the disaster happened, or how many persons lives were sacrificed, or how many poor souls were out on rafts or struggling in the water for their lives.
Capt. McIntire is well known to many of the people of Curry county, having at one time been in the employ of R. D. Hume at Rogue River.
So far as is known no blame attached to any one. The fog was very heavy at the time and the steamer no doubt getting somewhat out of her course struck on a sunken rock. The exact locality is not known, further than that it was in the vicinity of Cape Blanco. If the Capt. knows the locality, the tonnage and value of the steamer the value of cargo or number and names of passengers and crew it is nobody's business but his own. He arrived by the first boat and is feeling first-rate, after a good rest.
