Henry McBride, who has spent nearly a year at Bandon, returned to Port Orford Monday for a visit. He says that John Deadmond went up to Marshfield, to enter the Horseshoe hospital for treatment.

The Supreme Court of the United States held in the Williamson case, that after filing on land parties had a right to contract the sale of the land before title was obtained, although it was criminal to do so before filing.

Word was received by telephone last evening that Alf Gauntlett's little daughter, who has been suffering for some two or three weeks past with meningitis of the brain, is slowly improving and strong hopes are entertained for her recovery.

Oscar Nevgren, who drives the stage from here to Corbin, says that the Mussel creek hill washed out badly during the heavy rains, and that Monday the bottom dropped out of one small gulch, but the supervisor said he would have it repaired at once.

The Berwick left Coos Bay Sunday morning for Port Orford and Rogue river, but a south wind came up and delayed her arrival here, though supplies are short and anxious eyes are peering out upon the ocean to catch the first glimpse of her appearance.

Dr. Tyler was in town last Wednesday night on his way home from Gold Beach, where he was in constant demand as a physician. He is, of course, well pleased that the new road in his section was pushed through the County Court successfully, and to him, more than any one else, is the credit due.

Miss Calla Chandler began a term of school Monday in the Elk river district. A house at Adolphsen's mill has been fitted up for school during the winter months, as it accommodates a larger number of children at that place than where the school house is located further up the river.

There were more agates on the beach Sunday than at any time this winter, and the day being warm and sunny many people were out and some fine agates were collected. Port Orford challenges any other point on the coast to produce such a quantity and quality of gems, both as to value and variety as are found on Agate Beach.

Father Heinrich, a pioneer Priest long stationed at Roseburg in early days, and well known by the early settlers of Coos, Curry and Douglas counties where he was universally loved and respected by everybody regardless of creed, died at Baker City, Oregon, January 5th, from the results of a paralytic stroke received two years ago. He was 60 years of age.

Postmaster Curtis has received word that a pack horse, one locked mail pouch and a sack of paper mail were lost at the Brewster grade on the road between Roseburg and Sumner, while yesterday's mail was being brought to this city. The horse stumbled in some manner and fell over a cliff into the river with the pack of mail on its back and it is doubtful if the mail will ever be recovered.—Marshfield Times.

Registration books are now open. Notaries Public and Justice of the Peace, desiring to take registrations should apply to the County Clerk for supplies for that purpose. Registrations open on the first Monday in January—close for the primary April 7th—reopen April 21st—close for the General Election May 15—open for Presidential election Sept. 20th and close Oct. 20th. One registration is sufficient for the full election period—that is, a registration made in 1908, at any time the books are open, entitles the elector to recognition at any General, Special or Primary election held at any time thereafter up to the first Monday in January 1910.

COOS BAY NEWS.

On the last trip the Alliance made the run from Coos bay bar to the Columbia bar in 18 1/2 hours. If she keeps on increasing her speed at this rate, it is probable that a challenge will be issued to the Lusitania.

The owners of the Alliance made Capt. Olsen a Christmas present of a gold watch and chain, valued at \$250, in appreciation of his services in bringing the disabled steamer safely to port after the accident while crossing out from Coos bay on Nov. 28th.

The steam schooner Bandon arrived from Coquille, Friday, with about half a million feet of lumber on board, and took the balance of her cargo, 200,000 feet, at the Bay City mill. The Bandon was built at Porter last year by Kruse and Banks, and is of light draft, though she carries a large cargo.

While crossing out Saturday, the Breakwater was struck by an enormous sea, which stove in her fore-castle on the port side, seriously injuring four of the crew. A sailors' mate named A. Mollavia, a Spaniard, was terribly bruised about the head and body and both legs were broken. His injuries proved fatal.

The schooner Lucy, bound from San Pedro to Umpqua, was out 38 days Saturday. She was spoken off the Umpqua about two weeks ago, and is supposed to have been driven north by the late gales. Relatives of Capt. Peterson and the crew are beginning to feel uneasy about the vessel, fearing that she may have met with some accident.
