CURRENT TOPICS.

EDITOR TRIBUNE—

The voters of Oregon will be asked
to vote upon 19 measures at the
election. Briefly stated, the meas-
ures are as follows:

Submitted by the Legislature—
Amendment increasing compensa-
tion of members of the legislature
to \$400 for a regular session and \$10
a day for special sessions.

This amendment would not be so
objectional if it had not left
future legislatures at liberty to
make further increases.

Amendments permitting the lo-
cation of state institutions away
from the capital.

This ought not to pass for the
reason that institutions scattered
about the state, combine and cross-
cut for big appropriations as the
price of permitting good measures
to pass.

To increase the number of judges
of the supreme court from three to
five (by the legislature.)

This would have been all right if
the legislature had not superimposed
a rider suggested by lawyers in
quest of Judgeships providing for
abolishing County Judgeships and
making Circuit Judges also probate
Judges. This would gradually re-
sult in the multiplication of Cir-
cuit Judgeships.

Amendment changing the time of
holding general elections from June
to November.

This ought to pass unanimously.
It would save the time and expense
of one election every four years.

To give sheriffs exclusive con-
trol of county prisoners.

This is a special law applying
only to Multnomah County and in-
tended to increase the already large
patronage and emoluments of the
sheriff of that county. Vote No!

To require the railroads to issue
passes to all state, district and
county officials.

This was an act in contempt of
the people who had voted about 5
to 1 for the total outlawry of the
pass evil. I shall vote No!

To appropriate \$100,000 for Na-
tional Guard armories.

If the act did not give the so-
called Military Board a free hand
to build armories everywhere it
would not be so objectional. As it
is there would be no end to demands
for more money. Let us all vote
No! at a venture.

To increase the annual appropri-
ation for the State University to
\$125,000.

I submit a paragraph of the
Grange argument against this bill
which ought to defeat to say noth-
ing about the unfair methods of the
University crowd in securing the
paid insertion of their disingenuous
arguments in the papers. The para-
graph from the Grange argument
which is true is as follows:

"We maintain that the AMERICAN
COMMON SCHOOL is the 'head' of our
educational system, rather than the
University of Oregon. We hold
that it is much more important to
provide better common and high
schools, available to all the youth of
the State, than to grant the un-
reasonable demands of the State
University, the direct benefits of
which do not reach one-tenth of one
per cent of the people of the State.
Less than five per cent of the pupils
of the United States receive a Uni-
versity education; less than eight
per cent pass beyond the common
school course. In a great many
outlying school districts in Oregon
there is not more than four months

public school each year, because of
lack of money to pay teachers, and
teachers are scarce because poorly
paid. The University professor is
paid \$2,000.00 per year, and the
buildings are provided at State ex-
pense, while the school district
must tax itself to provide school
buildings. The State money avail-
able for each pupil in the common
school is little more than \$8.00 per
year. In this bill the University asks
\$339.00 a year per student."

(As a matter of fact the State
does not furnish \$8 but sometimes
a little more than \$1.50 per pupil,
the balance of the \$8 being raised
by a county tax.)

To extend suffrage to women.
This ought to pass. It is a re-
proach to the manhood of Oregon
that bums, vagrants and all the
back Indians of the State may vote,
and never fail to vote, while our
mothers and wives are relegated to
the class of convicts and incom-
petents.

Restricting the amount of fishing
gear on the lower Columbia and
providing a weekly and an annual
closed season.

If this could be voted on sepa-
rately it would be a good thing
since it prohibits fishing on Sun-
days and out on the bars at the
mouths of streams; but there is
another bill regulating fish wheels
and traps on the upper river, but
only one such bill would be
operative if both should pass; the
one receiving the highest vote hav-
ing the preference. Anyhow there
is no good reason why the voters at
large should intervene to save a
lot of scoundrels from themselves.
They have about all become million-
aires, though packers up there have
been compelled by the unions to
pay an average of \$1.65 apiece for the
same kinds of fish that Mr. Hume
has been paying less than 20 cents.

To give each city or town the sole
right to regulate its business houses,
theatres and the like on Sunday.

They dishonestly call this a
"Home Rule" measure, hoping to
sneak it through under false pre-
tenses. Cities and towns already
have complete Home Rule, under
the amendment adopted two years
ago, subject to the constitution and
criminal laws of the State, and it
is this limitation that the most
abandoned class of gamblers and
dice keepers seek to be rid of. Under
this proposed amendment brothels
even, would be legalized. Vote
No! loud.

To exempt improvements, ma-
chinery, factories, etc. from taxation
and place the bulk of taxes on land.

This would prove a most salu-
ary law, yet it may have been born
before its time.

To provide for the recall of pub-
lic officials and for the election of
their successors.

Premature again, it is to be
feared; but if we had it now we
would make short shift of Geo. A.
Steel.

Requiring all legislative candi-
dates to subscribe to Statement No.
One.

This is wholly unobjectionable
and will probably prevail by a
large majority.

To give political parties propor-
tionate representation in the legisla-
ture.

Born before its time again,
though good.

The corrupt practice act, limiting
the amount of money candidates
may expend for campaign expenses.
This ought and it is to be hoped
will, pass.

To take from district attorneys
the power of indictment and vest it
in grand juries.

This will surely be looked upon
with favor. It is too much power
to be safely entrusted to one man,
since we have not yet got into the
habit of electing saints as Prosecut-
ing Attorneys.

For division of Wasco county
and the creation of another county
with Hood River as the county seat.

Let us all sit down heavy on this.

and in the hopes and desires of
aspiring would be officers of any
new county. The Hood River peo-
ple ought to have profited by the
fate of the Barlow road grab.
