It is said that Honey will contest
the trial of Hermann at Portland
some time this fall. He has been try-
ing to get Hermann in the newspapers for
about three years, and perhaps with
the aid of his defective gang, believ-
ing he has the case ready for con-
viction. We opine that he will
have an enlightened public opinion
that is tired of "Honeyism and De-
fective Evidence."

Senator Gore of Oklahoma, in the
opening sentence of a speech at the
Democratic convention declared
that "Bryan was the greatest living
apostle of Human Liberty," which
the Delegates wild with enthusi-
asm, when they seized their banners
and 40 states marched and shouted
their cheers for Bryan for an hour,
celebrating any demonstration ever
accorded to any man in America,
and thus testifying that Bryan's
popularity was greater than it ever
was.

The battleship fleet left San Fran-
cisco on the 6th of July on its tour
around the world, under Admiral
Sperry. Every loyal American
wishes it God Speed, on its mission
of "peace and good will to earth."
If no mishap occurs the Atlantic
fleet will meet it in the fall in the
Mediterranean, where our entire
fleet will assemble and give to the
nations of Europe a sight of the
most formidable fighting navy the
world has ever known,—but all
Missionaries of Peace.

Theodore A. Bell of California as
Temporary Chairman of the Demo-
cratic convention at Denver, covered
himself with glory as an orator in
his "keynote speech," which is a
powerful arraignment of the Re-
publican party for what it did, and
"did not do" at the Chicago conven-
tion. Bell is but thirty six years
of age, and was practically an un-
known man; he is now a National
leader to be reckoned with. Bryan
had evidently heard the bell ring
before, and made no mistake when
he was selected for so delicate a
duty for one so young.

Senator Bourne will be in Port-
land soon, and expects to remain
in Oregon a couple of months.
The collapse of the Roosevelt im-
perial Bourne without political
occupation for the rest of the summer.
Though he lost the battle, yet he
was backed by more than three
fourths the people of Oregon, who
were defrauded of their choice by
a race convention of moss-grown
politicians. The Republican voters
had no more to do in nominating a
president this year, than the man
in the moon. Perhaps they will re-
member.

Bryan Nominated.

Bryan was nominated on the first
ballot by the following vote, Bryan
522, Gray 59, Johnson 46. J. W.
Keen of Indiana was nominated by
acclamation for Vice President.
The convention was one of the
most enthusiastic ever known.
The platform is long and vigorous
and covers all the reforms demanded
by the people. The two parties
have changed plans in leadership re-
form, aggression, and action—the re-
publican party having halted at the
command of the "interests."

A study of the two platforms will
show where the ice is, that will
freeze humanity and patriotism.
Minnesota was the only state
that voted solidly for Johnson, and
New Jersey—the Corporation state,
honored Bryan by casting the only
solid vote for Gray. "The third
time is the charm!"

Sherman, candidate for Vice
President on the Republican ticket,
got his kindergarten lessons under
Tom Platt of New York, and his
post graduate lessons under Jo Can-
ham, the trust protector. Sherman
is a banker—the "richest man in
Ethics," and the organizer, and head,
of the "Ice Trust." Even if Taft is
a friend of the common people, still
people would not trust him when
he runs with such company. No
national Convention ever acted so
blindly, or so brazenly in defiance
of public opinion as the Chicago
Convention, when it nominated
"Ice Trust" Sherman; voted down
the election of United States Sena-
tors by popular vote; and by a vote
of 50 to 1, refused to favor public
ity of campaign funds! And these
are not all.

kindles indignation and resentment.
It does not please the people of Ore-
gon that those trials be delayed for
years, for pursuance of spectacular
objects elsewhere, which, however,
also have failed. Binger Hermann
has been under indictment here for
years, yet never has been brought to
trial and never will be. All sorts
of charges have been thrown out
against Chas. W. Fulton, yet there
has been nothing but gas and wind
on which to base them. No wonder
public patience is exhausted.—
Oregonian.

CURRENT TOPICS.

Editor TRIBUNE.—It may or may
not be complimentary to the mem-
ory of the late Grover Cleveland that
the "great" Republican papers are
the chiefest eulogists of his life car-
reer, all depending upon the point
of view. In a signed article in the
Oregonian H. W. Scott expresses
surprise that Mr. U. ever pretended
to be a Democrat. The fact is he
never was a Democrat, since, like
Hamilton, he had no faith in or re-
spect for the Common, Plain Peo-
ple.

Mr. Cleveland's rise sufficiently
illustrates the fact that great things
may, and do often just happen. He
was nominated for Governor of New
York as the "lorn' hup," the politi-
cians of neither party suspecting
the intensity of the hatred of the
"Stalwarts" led by Roosevelt, Conk-
ling for the "Halfbreeds" led at that
time by Charles J. Folger who was
the Republican candidate. The re-
sult was that the "Stalwarts" by
thousands voted for Cleveland while
other thousands of them remained
away from the polls, the result be-
ing that Cleveland carried the state
by the phenomenal majority of
192,000.

This accidental triumph led to
his nomination for President against
Blaine, who would have been tri-
umphantly elected, if Rev. Theodore
Burchard had not "happened" to
furnish that choice irruption of
aliterative bombast "Ram,
Romanism and Rebellion." At
a great Blaine banquet in New
York City about the closing days
of the campaign. This foolish out-
burst lost New York State to Blaine
though by the remarkably narrow
margin of less than 1000 votes.

And it may be as well in this
connection to explain how Bur-
chard's foolish outburst wrought
Blaine's undoing. During his term
as Governor Cleveland had, at the
command of wealthy men and
wealthy corporations, voted a num-
ber of popular measures passed by
the legislature in the interest of the
common people, which showed that
he stood in line with Alexander
Hamilton's contention that "the
Government should take care of the
rich and trust the rich to take care
of the poor." The Irish Americans
whose inherited hatred of Hamilton
and Hamiltonism in memory of the
Alien and Sedition laws under
which several of their race had been

imprisoned and some transported,
had, many of them, under the lead
of the Irish World at the east, and
of the late John F. Finerty at the
west, broken away from Cleveland
and were enthusiastically support-
ing Blaine who had carried New
York State by many thousands, but
for the Burchard episode.

It will be remembered that Cleve-
land lost New York State to Harri-
son after his second nomination,
and would again in 1892 had not
the pinch of hard times struck the
country during the latter half of
Harrison's administration. So, it
will be seen that three times things
"happened," first, the "Stalwart"
and "Halfbreed" fight in New
York; second, the "Ram, Romanism
and Rebellion" episode, and third,
the hard times which were ap-
proaching panic proportions in 1891,
to throw matters Cleveland's way.
Neither merit nor even probability
favored any of his campaigns.
Things "happened" which thrust
him along. Fitness cut no figure.

And now comes the brigade of as-
sistant Republicans from the east,
masquerading as Democrats once
more, though none of them have
voted the Democratic ticket for nigh
on 15 years, with a scheme to force
through such a platform as would
sink Bryan. The assistant Repub-
lican brigade, Thos. J. Ryan, Aug-
ust Belmont, the N. Y. World and
some other wealthy exploiters of
New York, and Col. Guffy and his
gang of Pennsylvania's oppose Bry-
an's nomination ostensibly because
of his unavailability, but in fact be-
cause they fear that he will win out.

The proposition fattered by mil-
lionsaire scoundrels at the east to
force through the Denver conven-
tion a long resolution in laudation
of the late Grover Cleveland's car-
reer, and dwelling especially on his
life long fealty to the Democratic
party, is as an affront to Bryan
who was bitterly antagonized by
Cleveland in 1896 and 1900.

Henry Watterson of the Louis-
ville Courier Journal says of the
proposed Cleveland tribute: "The
attempt to drag the dead body of
Grover Cleveland from its new made
grave into the temple of a national
convention will deceive no one.
Nor was ever a professional ghoul
inspired by a more mercenary spir-
it, because the sole aim and end
of the Murphy-Coumers crowd, aided
by Judge Parker, is the perpetua-
tion of the ascendancy of the Bel-
mont-Ryan combination, to which
Democracy owes its last ignomin-
ious and well deserved defeat."

"If the primary election is good
for counties, small towns and vil-
lages to nominate candidates for
offices and delegates to county con-
ventions, why should not the people
be allowed the privilege of nomi-
nating the candidate for governor
of this state? As it is now sugges-
ted by one of the candidates, M.
W. Savage, why is it that the
machine politician is always decri-
ing the primary election? Simply
because there would be no grafting
or big rolling at the state and county
conventions. Give the common
people a chance to choose their
candidate by making their wishes
known through a primary election.
Why should not the parties, in call-
ing the primary election, have
printed names of all the candidates
for governor, and other state offi-
cials, on the ballot, so every voter
could express his individual choice?
Give the primaries a fair chance
and let the people decide these ques-
tions. Laws are made under the
supposition that they are to be ob-
served. If they are bad, repeal them.
The primary election law is in the
statute book, why not see that its
intentions are carried out in full
as to the letter and spirit of the act.
Give the common people a chance
and let them exercise their politi-
cal rights without aid of the slick
politician and slate-maker."
