We are having some very warm weather the last few days. The mercury standing at about 84 degrees on an average.

Sheep shearing and hay-making are the order of the day, and the musical sickles are heard on all sides. The hay crop is exceedingly heavy.

On last Tuesday a valuable mare belonging to the McVay brothers, of Chetoo, was kicked and had her leg broken and had to be shot, this being the third horse that has been kicked and had to be shot on the same ranch in the last few years.

The fourth of July celebration at Winchuck was well attended, there being about 400 people in attendance from different points. Some came from as far south as the Klamath. Hon. C. M. Benham, of Harbor, read the Declaration of Independence and also a poem. Miss M. Anderson was president of the day. The oration was by Thos. Berry Jr. of Crescent City, and was well rendered. After the usual exercises there was singing by the Glee club, and afterwards foot-racing by both big, little, old and young. There were other amusements to numerous to mention. There was lemonade for the ladies and candy for the babies. A basket dinner was served. The dance at night at the Harbor hall was well attended. The hall being packed to its utmost capacity, sixty eight people being present. It was said to be the most enjoyable time that ever occurred in this section. Ball tickets were sold at \$2.00 each, and supper 50 cents per plate. At about eight an automobile steamed into Harbor containing eight passengers, and the road was lined with buggies, carts and bicycles until a late hour at night.

The many delegates from Oregon and Washington are working hard to keep cool, and are working hard to enjoy themselves the best they can. Some of the old war horses are billing about conventions of the past and how they did things in the days gone by, and the young delegates who are in the majority only laugh, for they do things differently now, for at this age they know the people are doing some thinking, and it is the votes that elect a president, not brass bands and marching clubs; its the farming vote that counts this year. Empty dinner pails and slush funds don't get the farmers vote.

As I write this wastop at Payette, Idaho,—its cooler, some green trees growing, and again the train moves and more dust and heat, "Oh" for one hour on the Port Orford beach.

Two delegates, one from Idaho (an ex United States Senator) and the other from Oregon, and here is what the ex U. S. Senator says to the delegate from Oregon.
Speaking of our financial condition says the Senator you might have read what the British Commercial agent in the United States tells us, Mr. Seymour Bell, reports to parliament and you cannot overlook his report, he says:

"The cloud of uncertainty which has been hanging over the country for so long is now passing away and it may be said that the worst of the storm has now passed.

There will, in all probability, be mercantile disturbances for some months to come, readjustment and recuperation are well under way, and unless later troubles should retard the improvement, or monopolies of capital interfere to keep up prices at too high a level it is expected that before many months have passed business will be on a safer and more normal basis."

This opinion gains interest from the fact that it is the opinion of an outsider who is also an expert. The British financial agent sees us as it is, says the senator from a fixed point of view. He has no notion except to tell his folks at home the cold hard facts, whether they sound well to us or not.

The 250 pound senator sheds his coat dries his face and starts in. "For this reason Mr. Bell's allusion to causes of trouble is interesting, "when" he says, "by a failure in New York, light was thrown on the management of some of the large financial concerns of the city, public confidence, which had previously been undermined by certain agitation, gave way completely, resulting in an acute money panic." Mr. Bell calls attention to the fact the panic was entirely "financial." It was not industrial and did not affect the farmers. "The country," he says, "which produces crops valued at nearly \$7,500,000,000 is unlikely to suffer long from industrial stagnation.

Washington.—The interstate commerce commission has rendered decisions favoring the lumbermen, and against railroads in their attempts to increase rates to Missouri River points. The commission stipulates that all existing high rates must be discontinued on or before August 15, 1908.

Bryan's Tribute To Grover.

Lincoln, Neb., June 24.—William J. Bryan wrote a tribute to Grover Cleveland in which he declares the ex-president's death brings to an end a phenomenal career of one of the strongest characters of the present generation. Even those who disagreed with him were as ready as his warmest friends to concede to him the elements of leadership of an extraordinary degree. "Few men," says Bryan, "have exerted a more positive influence upon those associated with them." Concluding, Bryan says: "We are not far enough from the period in which his work was done to measure accurately his place in history, but qualities which made him great are a part of the nation's heritage and universal sorrow will be felt at his death."

Where Fortunes Grow On Trees.

(By H. S. Gray.)

In the Rogue River Valley, in Southern Oregon, F. H. Hakkins in 1907, made a profit of \$19,000 off 16 acres of Winter Nells pears—\$1,187.50 an acre. In the same valley G. H. Hover bought ten acres of pear orchard at \$560 an acre. Fifteen months later the crop brought him \$9600. Eight years ago J. L. Dumas set out 50 acres of apples near Dayton in the Walla Walla district of Southeastern Washington. In the summer of 1907 he bought 50 acres of apple orchard adjoining his property, at an investment of \$12,000. The apples he picked from these 50 acres that season sold for \$16,000, and the total crop from 100 acres realized \$52,000—a return to the owner of \$40,000. The statements are incontrovertible.
