COUNTY COURT PROCEEDINGS.

Be it remembered that at a regular term of County Court of the State of Oregon, for the County of Curry, begun and held at the court house in Gold Beach, beginning at the hour of Ten o'clock in the forenoon of Wednesday, the 7th day of July, 1915, that being the time and place provided by law for the regular convening of said Court at which were present: Hon. W. A. Wood, county judge, presiding, Delmer Colegrove and E. B. Sypher, commissioners, C. H. Bailey, sheriff, R. Standaard, clerk, and J. C. Johnson, District attorney, when the following proceedings were had:

The Clerk is hereby ordered to draw a warrant on the bridge fund in favor of J. E. Walstrom in the sum of One Hundred Dollars, same to be deducted from the contract price paid to Bandon Construction Co. for the Chetco bridge.

The Court proceeds to open the bids for the reconstruction of the Elk River bridge and the bid of S. P. Felton being the best and lowest bid for the same, it is hereby ordered that the contract be let to said S. P. Felton for the sum of \$1900.00, for reconstruction and painting of said bridge, and the further sum of \$325.00 for constructing a new approach to said bridge.

All road petitions before the Court are read for the first time as required by law.

The bond of C. H. Bailey as Tax Collector is approved by the Court.
