E. A. Lindberg returned home last evening from spending several days in Bandon looking after some of his father's affairs.

The steamer Centralia came into our port Saturday afternoon and landed several tons of hay and also some merchandise over the wire.

Mrs. W. R. Johnson has been taking a well earned rest from her duties as landlady of the Seaside and has been visiting relatives at Powers.

Gene Peirce went to the Coquille river last week after a small gas boat which he will use during the summer and fall deep sea fishing off this place.

Lillian Davidson returned Monday from spending a week in Bandon. She was accompanied home by two of her little cousins who will spend the summer visiting with her.

Geo. W. Laird has severed his connections with the Nestle Food company at Bandon and has moved with his family to the big Thrift ranch at Langlois which he and three associates bought last fall.

Harry Pearce arrived in Port Orford last Thursday evening and remained until Sunday visiting his parents at Middle Elk. Mr. Pearce holds a lucrative position with a corporation at Astoria.

Mrs. B. O. Johnson returned to Port Orford last week from Marshfield where she had been spending several weeks during which time she underwent an operation at the Mercy hospital.

Engineer Wm. Chandler, of Marshfield who has supervision of the state highway work in Coos and Curry counties, accompanied by Mrs. Chandler, was a Port Orford visitor during the past week.

Hans Adolphsen and George W. Sydnar were Denmark visitors in Port Orford last Friday. The former has his mill running steadily, and is engaged at the present time in sawing material for the local wharf.

Prof. F. H. Robinson, who left Port Orford several weeks ago for California, writes to have the Tatum sent to him at Rialto, which is 60 miles south of Los Angeles. He says they are now eating water-melons, cantaloupes, peaches and other good things down there.

Several Powers people were visiting in Port Orford the first of the week among whom was Will Miller, a former resident of Curry county. Mr. Miller says work is being rushed on the railroad into the Eckley country, about 200 men being employed on it.

C. L. Wakeman and family, of Wedderburn, passed through Port Orford Sunday on an auto trip to Willamette valley points. The Wakemans, who have been residents of the Wedderburn section many years, may decide to locate elsewhere to secure better educational facilities for their children.

Mrs. Herbert Unican and children, Mrs. Andy Ellis and children, and Miss Vera Wager, made a party who went to Gold Beach in the Unican car last Saturday and will remain until after the 4th. Mr. Unican accompanied the ladies, to drive over the hills as far as Corbin, from whence he returned home and Mrs. Unican took the wheel.

Wright, Mr. and Mrs. Delmar Wright, and Clarence Wright, made a party that motored to Gold Beach last Sunday to see the baseball game between the local team at that place and the Brookings team. Mr. and Mrs. Robt. Fromm, of Brush creek, also drove down to see the game and attended the dance the evening before.

Mrs. W. B. Milbury passed down the coast a few days ago enroute from her home at Oak Grove, Ore., to upper Chetco, at which latter place she will be stationed during the summer months as a fire guard, a position she efficiently filled last summer. This keeping a vigil for fires back in the mountains is a lonely job and one that would try the nerves of many men, but Mrs. Milbury says she likes it, having become interested in the work when her late husband was a Forest Ranger.

Mrs. Thos. Lane came down from her Coquille home last week to attend the funeral of P. J. Lindberg.

J. D. Loucks was a Bandon visitor one day last week. Mrs. Loucks is in Portland where she went to attend the festivities during last week. She will remain about a month visiting relatives in the Rose city.

Last week's Western World says there has been a change in the mail schedule on the trains that delays the lower Coquille valley and Curry county mail 24 hours four days in the week and 12 hours the remaining three days.

The 'norwest wind last week blew in one of W. H. Bennett's plate glass windows in his store on front street. The glass was 6x7 feet and valued at \$125. It had been weakened by being cracked from a rock which struck it near the center.

Marion Zumwalt was a Marshfield visitor last week, where he went to attend a big meeting of the Elks lodge. He came within one of drawing the lucky number that would have entitled him to attend the national convention of that order in Chicago as a delegate.

The steamer Bandon completed her deckload at this port last Wednesday evening after taking on board 200,000 feet of poles and ties. When starting to leave, she had some trouble with her machinery, and laid in our harbor until 10 o'clock the following morning.

Mel Fitzhugh sold one of his gas oiline launches last week to a fisherman who arrived here recently from the Umpqua and who expects to go to fish in the bay mainly for crabs, which are worth \$2.50 and \$3 per dozen. Mr. Fitzhugh is using his remaining gas boats for deep sea fishing.

Henry Adolphsen has been hauling sills for the wharf from the Denmark mill during the past week with N. H. Larson's Duplex truck. Some of the sills are over 50 feet long and weigh more than two tons each, yet Mr. Adolphsen brings two of them down over the rough roads at one load without trouble.

Thos. F. Hooper received a Ford truck last week which he planned on using for commercial purposes, however, he says it will not start for 'giddap' nor stop for 'whom', like the faithful horse he has been accustomed to driving, and he is a little undecided whether to try and master its peculiarities of pace it on to the next fellow.

The funeral of P. J. Lindberg in the Port Orford cemetery last Friday afternoon was largely attended, the services being conducted by Hon. John D. Loucks. The many beautiful floral offerings, which covered the grave deep, testified to the high esteem in which the deceased was held by the people among whom he had lived for nearly forty years.

Frank Dean returned to Port Orford last week, having come into Bandon on the steamer Elizabeth. He and his little brother, Lyman, and their grandmother, Mrs. B. W. Dean, had been spending the winter at Oakland, California. Mrs. Dean and Lyman started by train several weeks ago on their return here, but are visiting friends enroute.

The baseball game at Gold Beach last Sunday between the home team and a team from Brookings was a hotly contested affair, and the result was in doubt until the last man was out in the ninth inning when the score stood 9 to 8 in favor of the Gold Beach boys. Each team has some ex-league men in its line up, and the game was fast and snappy. It was also enlivened by the breaking out of some friction that has been existing between local and outside fishermen on Rogue river and some flatbills resorted to in which one or two black eels are said to have been received.

R. O. Gardner, of Langlois, who had a foot badly crushed on May 21, while working in the woods at the Waldvogel place splitting cedar cants is again able to be about, although it will be some time before he is completely over the effects of the injury. Two logs fell together catching Mr. Gardner's foot and leg between them. Mr. Gardner owns a fine stock ranch near Langlois. He has a herd of sheep on the ranch but intends to go out of that line of live stock business, owing to the depredations of coyotes. He has had 50 lambs killed by varmints this year.—Western World.

Rev. Cooper, Episcopal minister, from Coquille, will hold services in Port Orford, Friday evening, July 9th.

Go to Kansas City For Treatment.

Mrs. C. H. Pearce, of Middle Elk, started Monday for Kansas City, Mo., where she will enter a hospital for medical treatment. Mrs. Pearce has not been in good health for some time but did not think her condition serious until going to Bandon, Sunday, when Dr. Gale found her to be suffering from very high blood pressure. The hospital she will enter in Kansas City belongs to her husband's brother, who is an eminent physician of that city.

Mr. Pearce, who was foreman of the building of the wharf at Port Orford, resigned his position and has gone to their Middle Elk home during Mrs. Pearce's absence.

Mrs. Pearce has a large number of warm friends who hope for her return with her health restored.

Wm. Broome Arrived.

Sheriff Tolman and Robt. Walker came up from Gold Beach, Sunday, and returned to the county seat yesterday, having Wm. Broome in custody, whom they had arrested at his cabin on the south fork of Sixes.

Several months ago Broome was arrested and brought to Port Orford on a charge of assault with a dangerous weapon. Instead of being tried on that charge, however, he was examined as to his sanity and committed to the asylum. He created something of a sensation at the time by escaping from the officers in town, but was captured again at Sixes bridge.

It now seems there was some irregularity in Broome's commitment which caused the superintendent of asylum to parole him after he had been there a short time. He has now been re-arrested on the old charge and taken to the county seat for a formal examination.

Broome has been terrorizing the Eckley community for the past several years with numerous threats and gun plays.

Wind Prevents Deep Sea Fishing.

The fishermen who are gathered here to engage in deep sea fishing have so far been playing in rather hard luck. During the early part of the season, when the weather was favorable, the company was not ready to receive their catch, but for the past two weeks H. W. Miller, representing the Reedsport Fish Co., has been here to receive fish in any quantities. A northwest gale, however, has kept the boats anchored in the bay during this time. Until the wharf is completed here, and a gold storage plant in operation, the fish will be shipped fresh by auto truck and train to Reedsport.

Mr. Miller believes a business amounting to \$20,000 or \$30,000 a year could be developed here in the catching of crabs alone were it not for a law that protects them from July 1st to October 1st. This law, Mr. Miller believes, should be repealed inasmuch as it applies to an open roadstead like Port Orford where the crabs have all the ocean in which to recuperate their losses, and he intends to bring the matter to the attention of the next legislative session.

Historic Book Discovered In Archives Of Court House.

In looking over the old records at the court house in Gold Beach recently county attorney C. H. Buffington discovered an old record book of Jas. D. Burnett, commissary for 2nd recruiting battalion to the 2nd Rgt. O. W. V., in which appear the financial accounts of a detachment of Oregon Volunteers engaged in the Rogue River Indian War in the year 1856.

The comparison of prices then and now is interesting, and shows the cost of living in Curry was higher at that time on provision and groceries than at present. The following quotations give a good idea of the prices then prevailing:

Among the names of men mentioned in the book, who were afterwards well known residents of Curry county, were M. Riley, S. B. Blake and Charley Foster. The two former were each in charge of a mess of 12 men to which government supplies were issued, and it is noted that among the "necessities" given to each mess was a certain allowance of whiskey.

In the record is a brief account of a portion of the campaign of 1856 on Rogue river, which we reproduce below. Whether the attack on Kasateney had anything to do with the writer not completing his diary, we cannot say. The book has been sent to the Oregon Historical Society to be preserved.

June 1st—Made a forced march from camp at Oak Grove to Big Bend, distance 26 miles, and encamped in the vicinity of the regular forces under Lt. Col. Buchanan. That evening several shots were fired which was supposed to be the signal of attack by the Indians under John. Col. Buchanan invited Capt. Bledsoe to take up a position inside of the picket guards on the east side, which was complied with. No attack was made.

2nd—Remained in camp.
3rd—Expedition started for Big Meadows, and had gone about two miles when they discovered several bodies of Indians supposed to be John's bands. Capt. B. immediately marched to attack them; nothing further seen of them, they probably had fled. Expedition again sent out, and returned the 4th.

5th—Took up our line of march for the mouth of the Illinois river accompanied by regulars under command of Major Reynolds. Surprised a band of Indians who were fishing about two miles above the mouth of the Illinois; killed three of them and captured four canoes. Encamped that night at the junction of the Illinois and Rogue river.

6th—Marched to attack the main body of Indians, some four miles below, who were reported three hundred strong, the regulars under Major Reynolds remaining in camp. Our company of regulars under Capt. Augur marched to attack the Indians on the opposite side of the river, the plan of attack was to be a simultaneous one, the volunteers attacking them upon our side, and the regulars upon the opposite side of the river. The battle lasted 26 minutes, the volunteers killing eight Indians and taking several women and children prisoners, the regulars killing six, completely routing and dispersing the enemy who were seen flying in all directions. Returned to camp that evening with the loss of one man, James Bray, missing, supposed killed; one man, J. A. J. McVay, slightly wounded, and one man, Jas. D. Didway, severely wounded, shot through the fleshy part of the thigh.

7th—A detachment of twenty men sent in pursuit of the missing man returned without getting any trace of him.

8th—Adjutant Munson came to camp from General Lamerick. Capt. Bledsoe returned to Big Bend with Munson.

9th—Capt. Bledsoe returned to camp.

10th—Gen. Lamerick and command reached our camp at the mouth of the Illinois.

11th—Gen. Lamerick with the entire command marched on the Kasateney ranch. Encamped about five miles opposite to it on the mountain.

12th—Three companies of the 2nd Rgt. including Capt. Bledsoe's company ordered to the attack of the Kasateney village, also to burn and destroy everything belonging to the Indians.

In connection with the above it might be interesting to note that about this time occurred the fight of Capt. Smith with the Indians at Big Bend in which he came very near losing his company by a military oversight. When attacked by the Indians, instead of keeping his position by the river with an open valley all around him, he fought his way to a brushy ridge half a mile northward and entrenched, without water. The Indians fell back in front and let him in, the brush more easily than they intended to let him out. There he was, speckled and hopelessly surrounded, and had it not been for Charley Foster, all would have been killed. Foster, who was well acquainted with the country and had distinguished himself as a scout and guide, stole out in the night and worked his way through the surrounding savages and sped away to the mouth of the Illinois river, about ten miles below, where Col. Buchanan's command was encamped. A relief party, guided by Foster, was immediately sent out, and appeared before the astonished savages at 10 o'clock the next morning who fled up the river after firing the last hostile shots ever fired in that valley. About half of Capt. Smith's command had been killed or wounded.

Buchanan, Smith, Augur and Reynolds a few years later distinguished themselves as leaders of the union forces in the Civil war.
