WAITING UNTIL AFTER ELECTION

R. R. Heads Halt Further Expen- ditures

TO CONTINUE LINES NOW BEING BUILT

Declaration Made That Political Atmosphere Must Be Cleared

The Portland Telegram has the following on the railroad situation:

No new railroad work will be started in Oregon nor will there be any expenditures other than are absolutely necessary until the present political situation shall clear, as the news given out by prominent railroad men.

The railroads are drawing in and expect to retrench even more until the unsettled political condition shall become readjusted. Having spent approximately \$20,000,000 in Oregon the last two years, the transportation companies are curtailing their outlay.

The Oregon Trunk had let a contract for constructing a piece of road between Bend and the Klamath Indian Reservation, continuing the line from Bend. J. F. Stevens has called off this work already and is not prepared to say when it will be resumed. The extension of the Oregon Electric from Albany to Eugene

will not be pushed through as had been contemplated, the Eugene Councilmen extending the period for the work to 30 months, although the road can be built at least in 18 months.

As for the Harriman system, all work which has been started and under way will be carried on but there will be no new work started. No improvements will be considered in any manner except such as become absolutely necessary. The double tracking near The Dalles and the work in the Deschutes will be continued, for appropriations have been made and the work mapped out, but nothing under the head of new business will be taken up.

"For the last five or six months I have been spending \$1,000,000 a month in Oregon," says Mr. Stevens, "but I do not know how much longer I can do it."

It is estimated that the various roads in Oregon and along Washington adjacent to Oregon have spent \$20,000,000 in the past two years, 80 per cent of which has been kept in circulation. The Harriman system has contracted for 60,000,000 feet of Oregon pine for use in constructing cars this year.

New Postoffice to Be Established

Prineville Journal: A petition has been forwarded to the post-office department asking that a postoffice be established on the east side of Powell Butte. Almost 100 patrons would be served by such office and the place will be named Hat Rock.

Will Organize a Dancing Club

A number of the dancing people of Redmond have been talking of organizing a social dancing club here to give a series of dances during the winter months. It is understood that a hall has been secured and about twenty people have signified their intention of joining.

BEND MAN IS CANDIDATE

Millard Triplett Seeking the Nomination for Sheriff

Millard Triplett of Bend, republican candidate for the nomination of sheriff, needs no introduction to the voters of Crook county. He is one of the early settlers in the county, has been a prominent business man in Bend for a number of years, served on the city council of that city for several years, has been deputy sheriff under the present sheriff, Frank Elkins, and is a man not afraid to declare his principles and live up to them.

Mr. Triplett stands for the enforcement of the law as prescribed on the statute books, and he promises the people of the county that if nominated and elected he will see that the laws are enforced to the letter. He believes that if a law is obnoxious to a few, that that is no reason why it should not be rigidly enforced.

Mr. Triplett has a strong following in the Bend section of the county that is working to secure the nomination of their candidate, and his friends ask all the voters of the county who are in favor of a clean, upright administration of affairs in the sheriff's office to cast their vote for him for sheriff at the primary nominating election the 24th of this month.

Swear in Vote At Primary

Attorney-General Crawford, giving an opinion at the request of H. C. Patty of Amity, holds that any elector has the same right to vote at the district primary nominating election as he has at the general election.

The question specifically asked the Attorney-General by Mr. Patty was in reference to the use of the blank "A" which is for the purpose of "swearing in" voters. The Attorney-General holds that this blank may be used at the primary election and in the same manner, the vote being sworn in by six free-holders.

He states that it is not within the province of the Legislature to say a man shall not vote if he has not registered. He urges at the end of the opinion, however, that every one should register who can possibly do so, as the requirement of securing six freeholders to "swear in" the vote causes considerable confusion and consumes a great amount of time in many cases.
