Marshal Gives Up Keys

Madras Pioneer: At the meeting of the city council held Tuesday evening that portion of the ordinance relating to the closing of saloons 12 o'clock Saturday night which required the proprietors to turn over their keys to the marshal until the following Monday morning, was rescinded. The effect of the order was only to cause trouble and inconvenience for the marshal and the saloon men, and upon protest from the latter the council decided to let the proprietors be the custodians of their own property.

COSTS BEND MAN TO KEEP DOGS

To be compelled to pay taxes on his hounds at the assessed valuation of \$50 each and to be held up for an additional license fee by the city has aroused S. G. Dorris of Bend and he has written the attorney general's office to see if he can not get what he believes to be a square deal. Second Assistant Attorney General James W. Crawford answered Mr. Dorris by explaining that if the license fee charged by the city were for revenue purposes it would be double taxation and illegal but that the city council has a right to impose a license on dogs for regulative purposes. Dorris' hounds are blooded and are used in hunting big game, but he declares they are costing him more in taxation than ordinary horses as he has to pay for both a personal property tax and a city license on them.

Round House At Metolius

According to the Metolius Oregonian work on the round house at that place for the Oregon Trunk Railroad was commenced last week. The house is to consist of two sections of eight stalls each. The round house will be used, under a joint agreement, by both the Oregon Trunk Railroad and the Deschutes Railroad. The bulk of the equipment now installed in the North Bank round house at Cliffs, is being transferred to Metolius as the building of shops at the latter place makes the round house at Cliffs unnecessary.

A large tent is being erected on the corner of 7th and D streets in which a series of meetings will be held by the Seventh Day Adventists.
