**LOWER BRIDGE  
IS PROSPERING****LAND IN THAT SECTION IS BEING RECLAIMED AND DEVELOPED**

Few people in the county, and few even around Redmond, realize the importance and real significance of the work being done at the present time on the west side of the Deschutes river.

Under the ruling of the State Board of Control, rendered last May all lands receiving or expecting water for irrigation purposes from Squaw Creek, must be put into condition for irrigation before October 1, 1912.

At the time the decision was rendered there were approximately only 6000 acres really being irrigated under this stream, and the matter of the water waste thereon had long been quite a scandal in the eyes of the State Board. Last summer the state put a man in charge of the distribution of the water, and as some 20,000 acres were claiming water under the adjudication, the people left off ponding their fields and settled down to real work, with the result that this section is now undergoing a season of industry and development not only unparalleled in its history, but also unequalled in any other section of the county.

The people are beginning to realize the difference between irrigated lands covered with rocks, trees and sage brush, and the same lands in clover, alfalfa and hogs.

Within a radius of four miles of Lower Bridge, on the west side of the river, there is a large body of this land rapidly yielding up its growth of scraggy junipers and sage brush and receiving into its brown bosom the all important and all sufficing artificial rain.

W. A. Dalton, who has a 40-acre tract, has just completed a contract of enlarging the old West and Rubble ditch for Messrs. J. R. Howard, L. A. Hunt, G. T. Scott, Roy L. Kidder and others, to a canal sufficient to convey the allotted four-fifths of a miner's inch per acre to over 1200 acres.

During the summer the Black Butte Land & Livestock Co. will enlarge its present canal to accommodate other ranchers, and by October first it will be conveying water to nearly 2000 acres. These two canals together with the old ditch, will water about 4000 acres.

This section has several natural advantages that are bound to count within the next few years. The average elevation is about 2700 feet. The soil in the main is a very deep sand loam with a gravel subsoil. It is protected from cold winds by high ranges of hills, yet being in the nature of a second bottom it is quite free from frosts; furthermore, the land is unusually free from surface rock, and lies in a compact body.

The greater part of this land at the present time is held in large tracts, but as soon as this season's development is over most of it will be broken up into 40 and 80 acre tracts.

A fine new school house will be built here this summer to cost from \$1200 to \$1500.

Lower Bridge is located about 7 miles from Terrebonne, and about 11 miles from Redmond, giving this section a good outlet to the railroads.
