#### POTATO SHOW AND FAIR CITY MARSHAL DIDN'T MAKE HIS CASE STICK **OPENS TOMORROW**

Everything is in readiness for the opening of the Second Annual Redmond Potato Show and Fair which will be opened tomorrow, Friday, and continue over during Satur-The Show was originally intended to be held under large tents near the center of the business section of the city, but this arrangement has been changed and the event will be held in Anker's hall on north 6th street.

Exhibits have been coming in all the week from different sections and the committee having this branch of the Show in charge has been busily occupied labeling and placing them.

Friday evening at 8 o'clock a Farmers' Institute will be held, the program of which appears elsewhere in this issue. The premiums for different classes of exhibits are all liberal and will bring out a large display of all kinds of ag-

ricultural products. No resident of Redmond is allowed to compete for premiums. They may place their exhibits in the show and that is as far as they can go.

The advertising committee has put over a nice stunt to advetlise the show outside of the city. One thousand pint paper boxes containing Saratogo Chips, made from Redmond grown potatoes, and advertising the Show, have been sent out for free distribution among passengers on west bound trains from Spokane on the North Bank road, and from Pendleton on the O.-W. R. & N. The boxes have also been distributed free on Oregon Trunk and Deschutes railroad trains coming into this section.

Free band concerts will be given both Friday and Saturday evenings by the Redmond Concert Band.

The railroads have made a round trip rate of one and a third fare for the Show, and that will aid much in bringing in a number of people from outside towns.

"NO CASE" SAID THE CITY RE-CORDER IN BARHITE ARREST CASE

City Marshal C. A. Adams last week swore out a complaint before the city recorder, charging C. J. Barhite, proprietor of the Cafe Royal in this city, with selling liquor on Sun-

When the case came before the recorder last Thursday forenoon Marshal Adams and O. L. Johnson, who acted as a spy with Adams, testified they had seen men go into the room next to the Cafe Royal saloon and that Barbite poured them out drinks from a bottle. These two spies said they were in the back yard of the saloon property and looked in through an open door, about 50 feet distant from where they stood, and saw beer poured out from a bottle

Mr. Barbite in defense testified that he lived in the room adjoining the saloon, and had a perfect right to be there; that the saloon part was closed all day Sunday; that several men came to his room and asked for liquor, but he refused to sell or give it to them.

Upon hearing Mr. Barbite's side of the case the recorder threw the case out of court, and Marshal Adams and Spy Johnson were informed that in future when they brought cases before the recorder they must have reliable enough evidence to substantiate their claims.

### McFARLANE SURE TO BE ELECTED COUNTY JUDGE

Coe's Candidacy Is Considered

a Joke by a Majority of Crook County Voters---Springer Losing Ground Fast all Over the County, and McFarlane Gains

Carefully gleaned reports from the different sections of † the county, and particularly from the precincts of Prineville, Sisters and Madras, assure the election of G. A. Mc-Farlane of Redmond, for county judge by a large majority.

The ridiculously false statements now appearing from time to time in the Bend Bulletin in regard to the support which is being received by Dr. Coe, who is being put forward by the First National Bank and timber interests of Bend in a brass band campaign, and a fruitless effort to control county business and county funds, is certainly very amusing to anyone who will stop to consider the situation.

Some of the papers of the county that are copying these articles in answer to a liberal application of the slush fund of what is self-styled the Coe Campaign Committee, would do well to stop and consider the fact that their respective communities are not in sympathy with such methods, or with the candidacy of Coe.

It is also amusing to note the attempt on the part of the Bend Bulletin to flirt with some of the smaller towns which heretofore it has wholly ignored, and will continue to ignore after election, regardless of results. We also note the fact that Mr. Springer, not being an

attorney, is losing him the support of many Democrats who are now openly advocating the election of Mr. McFarlane. It is now a foregone conclusion that Mr. McFarlane, the Republican nominee, will receive the unanimous support of all decent Republicans in the county, and indications now are that he will carry the Bend precinct by a good majority, as many citizens of Bend are opposed to the candidacy of Dr. Coe at this time and are rallying to the support of McFarlane.
