

One of these positions would be eliminated by the proposed change.

The governor said the measure would be initiated by the people of Central Oregon.

The present incumbents of the offices who will be affected by the proposed change are John H. Lewis, State Engineer: James Chinnock of Salem, superintendent of water division No. 1, and George T. Cochran of La Grande, superintendent of water division No. 2. All are candi dates for re-election. As members of the State Desert Land Board hold other state offices, they would not be affected.


