Vote NO on the Reddy Measure. What is the "Reddy Measure?" It is a petition submitted by Dr. J. F. Reddy, of Medford, and filed with the Sec'y of State under the initiative Act, which proposes to give cities the exclusive right to license and regulate saloons without any regard to State law. Other things are mentioned in the petition, such as theaters, race-tracks, pool-rooms, etc., but it is evidently the last resort of the liquor men to overcome the local option law. The Constitution of the State now provides "that city charters must be subject to the State Constitution and criminal laws of the State." This proposed law, if passed, simply means "wide open" saloons in our towns and will rob our local option law of its power. It would also take away the

power of sheriffs and District attorneys to suppress Sunday saloons, pool rooms and all such places, and give municipal authorities power to run a town as wide open as they desire. The proposed amendment would undermine the supremacy of the State.

The people of Oregon cannot tolerate such tampering with her Constitution, and the vote against this measure should be so overwhelming as to discourage any future attempts in the same direction.

The proposed Amendment is entirely superfluous, since all cities and towns in the State of Oregon do now enjoy the fullest possible "home rule," having absolute self-government—the right to make and amend their own charters and enact their own laws, as we have already said, subject only to the Constitution and the general criminal laws of the State.

Vote 321 NO.

We are trusting that Stayton will roll up a large majority of votes in favor of local option or County prohibition.

Abolish Merciless Fishwheels Says David Starr Jordan

President of Leland Stanford Junior University Writes on the Columbia River Salmon Crisis.

Stanford University, Cal., May 13, 1908.—Mr. Edward Rosenburg, Astoria, Oregon. In response to a request from Mr. Hylan I am giving you my opinion as to certain matters connected with the salmon fishing in the Columbia. As you know, I was the first Commissioner ever sent out to investigate the salmon. I spent some time in Astoria in 1880 and I have made a number of visits there or farther north in the same interest since then. I have not changed my opinion in this time as to these matters.

(1) The fish wheel and the stationary trap in the Columbia river should be abolished. It would be well for the fishing interests of the country if the stationary trap in all of its various forms was eliminated, for this is the most destructive and indiscriminating kind of fishing. On the Columbia where the river is narrow and swift, the fish wheel is not only very destructive, but has the additional evil effect of (a) taking work from the fishermen, and (b) of taking the fish when they are not in the best condition, for fish for canning ought to be taken in tide-water.

(2) It would be well if all fishing on a large scale above tide-water in the Columbia should be prohibited. I would also recommend that a careful study of gill-net and similar methods of fishing be made, with a view to the ultimate interest of the fishing industry, as even if worse forms of fishing were eliminated, there are still perhaps too many gill-nets for the size of the river.

To prohibit gill-net fishing after dark would virtually destroy the effectiveness of that industry at all

times when the water is clear.

Your Committee has examined into these two bills as far as their time would permit and have to report that we favor proper protection to all natural spawning grounds; and to that end we condemn as a great detriment to said industry and to our State the operation of FISH WHEELS in the narrows of said river and demand and urge the passage of a law removing the same and also further recommend that said law shall be so constructed as to remove all traps from said stream.

"JAYHAWKERS OF '49."

The Death Valley Magazine, which is publishing the life of Death Valley Scotty, will begin the story of the "Jayhawkers of '49" in its May-number. The "Jayhawkers" discovered and gave Death Valley its name. The story will be written by John B. Colton, one of the survivors, who is now 75 years of age. He was the youngest member of the party, being 16 years old at the time.

April 5, 1849, the party, consisting of 36 members, organized at Galesburg, Ill., under the name of "Jayhawkers," and started to the gold fields of California. They were on foot the last 52 days of the trip, having abandoned their wagons and butchered their oxen for food.

There are four survivors, one a woman aged 94 years, who carried a child upon her back and kept in line while strong men fell dead or went insane upon the trail.

All of the story will be told for the first time, the humorous as well as the pathetic. Publishers have sought it for 50 years, but the survivors have now deemed it fit and proper to give it to the Death Valley Magazine.
