#### ELECTRIC LINE ASSURED.

On Saturday evening a large massmeeting was held in the city hall for the purpose of discussing the electric line project. The meeting was called to order by Mayor Freres who gave a pointed address which was followed by several other business men.

The procuring of an electric line localities is unknown here. for our town means transportation The following is the report of City facilities and the elimination of the greatest barrier of Staytons growth.

With but a short time in which to raise the (required sum asked for by A. Welch, representative of the Oregon Flectric Company, a special committee for that purpose made their first report which showed general finincial interest being taken by our citizens, the subscriptions reported being above the ten thousand dollar mark.

It is now an assured fact that the Oregon Electric will build to Stayton in the very near future. Our citizens have taken up a large per cent of the \$100,000, first mortgage bonds which pay six per cent interest semi-annually with the future consideration that the Oregon Electric Company through its agent A. Welch aggrees to take up any or all subscriptions paying par value there-for at any interest paying period.

The taking of stock in this enterprise means the best investment for the surplas capital of this or any vicinity. Not only does it mean the building of an electric line, but the removal of the greatest hindrance to Staytons growth - transportation. With the accomplishment of this of this undertaking this entire territory will rapidly be settled up, timber products, farm produce, stock etc., can be sold at home to an advantage and every one will be benefited. It may seem to some that A. Welch is asking a subsidy for his road but such is not the case for he agrees to take up any subscription given together with six per cent interest semi-annually this to | Confectionary. be at the option of the subscriber.

In addition to giving this section transportation and railroad facilities the new electric line brings the assessed violation of Marion county into a new class to the tune of \$388,000. Now is it not a fact that every citizen who makes a loan on the electric line has availed himself of the best industrial security offered any community. The work of the special committe is being greatly commended and appreciated by all and let the last six months of the year prove the best Stayton and vicinity have ever known.
