In closing my campaign for circuit Judge I wish to thank one and all for the kind treatment I have received, and particularly the newspapers which have voluntarily published editorials about me which I had hardly expected.

While the labor and expense of the District primary campaign is onerous, I still cling to the belief that it is an improvement on the old convention system, and particularly in the larger cities.

E. H. BELKNAP

Candidate for Representative on the Republican Ticket.

Edward H. Belknap, who is a native son of Oregon, born of early pioneer stock on a farm in Benton county in 1860 is a man of pleasing personality with a strong and vigorous face. INDUSTRIAL SCHOOL FAIR WILL BE HELD

At the Parent-Teacher's meeting in the high school auditorium Friday at 2:30 p. m., the constitution and by-laws of the Stayton Industrial School Fair, as prepared by Attorney Heltzel, were adopted as a whole. The following board of directors was elected: A. Fery, Geo. Keech for one year; S. H. Heltzel, E. C. Downing for two years; and E. M. Olmsted for three years.

At a meeting of the board of directors the first of the week, A. Fery was chosen President; Geo. Keech, vice president; S. H. Heltzel, secretary; and E. M. Olmsted, treasurer.

It was also decided to get out a personal letter to every family, whom it is possible to reach, inviting them to become a member of the Fair.

The membership fee is set at one dollar per year, and committees will be appointed to solicit for memberships.

It will be no hardship for anyone to give a dollar toward the Stayton Industrial School Fair, and many people will take two or three membership certificates or buy one for several years.

The board is already planning the premium list, and a word here to the young people will not be amiss.

Plant and take care of your gardens. Prepare for the Fair, for there will surely be one in Stayton from three to ten days before the state fair.

The list will be gotten out as soon as possible, but don't wait, begin now.

Stands on record. He has practiced law in Marion County for twelve years and is a member of the well-known law firm, Carson & Brown, Salem, Oregon. He was a member of the last Legislature and actively supported all of the best measures passed during that session.
