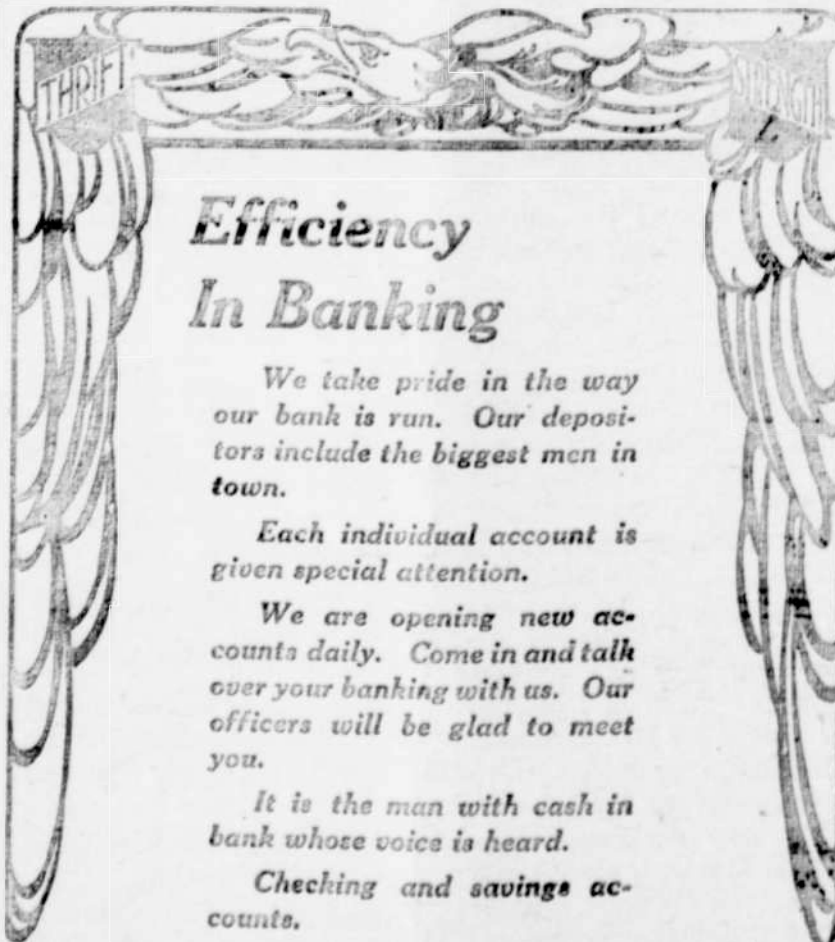
This meeting is called for the purpose of electing One Director for three years and One Clerk for one year and the transaction of business usual at such meetings.
